<u>AGREEMENT</u>

THIS AGREEMENT, made between the City of Huntsville (AL) Police Department (hereafter "AGENCY") and Paul Butler Presentations (hereafter "CONTRACTOR"),

WITNESSETH

That, in consideration of the mutual benefits and detriments identified herein, AGENCY and CONTRACTOR hereby agree as follows:

- 1. <u>Contractual Status.</u> CONTRACTOR will perform the services required herein as an independent contractor and will not thereby become an **AGENCY** employee.
- 2. <u>Time of Performance.</u> The agreed upon work will occur in the period commencing on June 5, 2023 and ending June 6, 2023.
- 3. <u>Scope of Work.</u> CONTRACTOR will provide two days of training on policing leadership to include two sessions on June 5, 2023 and two sessions on June 6, 2023. All training will occur in the Madison/Huntsville area at a location to be determined by AGENCY, which shall be permitted an unlimited number of attendees provided such attendees are employees of AGENCY.
- 4. <u>Compensation.</u> The AGENCY agrees to compensate the CONTRACTOR in the total lump sum amount of \$12,500.00 for the work specified above. Payment will be made at the conclusion of services or sooner if AGENCY chooses. The payment will be made only upon receipt of a written invoice from CONTRACTOR.
- 5. <u>Administration.</u> The Chief of Police of AGENCY will be the administrator for this contract and responsible for approving payment to the CONTRACTOR.
- 6. <u>Taxes.</u> The CONTRACTOR is an independent contractor and as such shall be responsible for all taxes; the AGENCY will not pay or withhold any taxes. The CONTRACTOR'S correct taxpayer identification number is provided below, with CONTRACTOR'S signature.

- 7. Warranty. CONTRACTOR warrants that all services provided under this Agreement will meet or exceed contemporary professional standards in law enforcement training and will hold AGENCY harmless for any liability that occurs as a direct result of CONTRACTOR'S proven negligence in this service provision. Otherwise, each party is responsible for their own liability exposures.
- 8. <u>Termination of Contract.</u> Either party may terminate this Agreement for any reason but only upon thirty (30) days written notice to the other party. Notices may be rendered to the AGENCY at its offices in Huntsville, AL and to the CONTRACTOR at PO Box 911, Aynor, SC 29511.
- 9. <u>Situs.</u> This Agreement shall be governed by the laws of Alabama and any suit for breach or enforcement of the contract shall be filed there.
- 10. <u>Assignment.</u> Work under this agreement may not be assigned or transferred by the **CONTRACTOR**, who must perform all work personally.
- 11. <u>Signatures.</u> The parties agree that any form of electronic signature, including but not limited to signatures via facsimile, scanning, or electronic mail, may substitute for the original signature and shall have the same legal effect as the original signature.

IN WITNESS WHEREOF, the AGENCY and the CONTRACTOR have executed this Agreement in duplicate originals, one for each party, this the 27th day of April, 2023.
