SPECIAL EMPLOYEE AGREEMENT BETWEEN THE CITY OF HUNTSVILLE, ALABAMA AND ODESSA NEWSOM

(STATE OF ALABAMA) (COUNTY OF MADISON)

AGREEMENT BETWEEN THE CITY OF HUNTSVILLE, ALABAMA AND ODESSA NEWSOM

THIS AGREEMENT is made and entered into on the <u>19th</u> day of <u>December</u> 2024, by and between Odessa Newsom, an individual, ("Newsom") and the City of Huntsville, Alabama, a municipal corporation in the State of Alabama ("City"),

WITNESSETH:

In consideration of the mutual promises and covenants herein contained, the parties do hereby agree as follows, to wit:

- 1. Newsom shall be employed by the City of Huntsville, Alabama as "Special Employee" in the Engineering Department and shall be classified as a "Special" employee under the City's Personnel Policies and Procedures Manual.
- 2. The term of this contract shall be for a period of one (1) year commencing on January 1, 2025.
- 3. This contract may be terminated by either party upon thirty (30) days written notice being provided to the other party.
- 4. During the term of this contract, Newsom shall perform the duties and responsibilities of a Special Employee described as follows; Work involves performing professional accounting or fiscal work and planning and directing the work of accounting and other staff in the maintenance of an accounting, auditing, and/or fiscal program. Work is performed with considerable professional independence according to professional standards, City ordinances and regulations, state law, and federal law and regulations. Work shall be under the direct supervision of the Director of Engineering.
- 5. In consideration of the services rendered hereunder, City shall pay to Newsom at the rate of \$28.00 per hour, not to exceed 29 hours per week, with the total sum Not-to-Exceed \$38,000.00 per year which shall be paid bi-weekly in accordance with City's regular, payroll processing system. During the term of this agreement, Newsom shall not receive any cost-of-living adjustment approved by the City Council for all other employees of the City. In addition, Newsom shall not receive any benefits available to any employee of the City except those benefits she receives as a result of being retired from regular employment with the City.

Newsom shall have no authorization to incur any debt or obligation on behalf of the City. Newsom shall not receive any benefits available to any employee of the City except those benefits she receives as a result of being retired from regular employment with the City.

- 6. Newsom acknowledges that confidential information in the way of financial practices, internal activities and operations, may be made available to her in connection with her work pursuant to this agreement. Newsom agrees not to disclose the confidential information to any third party at any time following execution of this agreement. This clause shall survive the termination of this agreement.
- 7. Except as specified herein, Newsom shall be subject to all policies applicable to part-time employees.
- 8. This agreement constitutes the entire agreement between the parties.
