WHEREAS, the City of Huntsville, Alabama previously entered into an agreement between First Stop, Inc., for services pursuant to a grant award for FY20 Community Development Block Grant-Coronavirus (CDBG-CV) No. CV-EC-20-101 from the Alabama Department of Economic Affairs under Coronavirus Aid, Relief, and Economic Security Act of 2020 or the "CARES Act," and

**WHEREAS**, First Stop, Inc. requested to amend Section I (BUDGET) and Section II (TIME OF PERFORMANCE) of their agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, that the Mayor of the City of Huntsville is hereby authorized, requested and directed to execute <u>"Modification No. 1 to the Agreement between the City of Huntsville, Alabama and First Stop, Inc. for the use of ADECA CDBG-CV funds,"</u> consisting of two (2) pages, and the date of <u>December 1, 2022</u>, appearing on the margin of the first page, together with the signature of the President or President Pro Tem of the City Council, an executed copy of said document being permanently kept on file in the Office of the City Clerk-Treasurer of the City of Huntsville.

# **MODIFICATION NO. 1**

THIS MODIFICATION IS MADE TO THE AGREEMENT entitled "Agreement Between the City of Huntsville, Alabama and First Stop, Inc., as approved by Resolution No. 22-374, for the use of ADECA CDBG-CV funds" as referenced above and is entered into on this the <u>1st</u> day of <u>December, 2022</u> by and between the City of Huntsville, Alabama (City) and First Stop, Inc. (Agency).

#### WITNESSETH

**WHEREAS,** the Agency has indicated a need to amend their Budget (Section I) and Time of Performance (Section II);

**NOW THEREFORE**, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

Effective <u>December 1, 2022</u>, the Budget (Section I) and Time of Performance (Section II) of the Agreement is deleted and replaced with the following:

# I. <u>BUDGET</u>

The CDBG-CV funds shall be during the time of performance and shall be expended as delineated in the budget below:

# II. <u>TIME OF PERFORMANCE</u>

Services of the Subrecipient shall start on <u>May 4, 2022</u> and end on <u>December 1, 2023</u>. The term of this Agreement and the provisions herein shall be extended to cover any additional time period during which the Subrecipient remains in control of ADECA CDBG-CV funds. The Subrecipient shall forfeit all funds not expended by the end of the term of this Agreement.

The Parties agree that any form of electronic signature, including but not limited to signatures via facsimile, standing, or electronic mail, may substitute for the original signature and shall have the same legal effect as the original signature.

All other terms and conditions of the Original Agreement remain unchanged and in full force and effect.


