RESOLUTION NO.	22-

**WHEREAS**, certain property has recently been annexed to the City of Huntsville, Alabama; and

**WHEREAS**, said property is now legally part of the incorporated municipality of the City of Huntsville, Alabama, and as such is subject to the laws and ordinances governing the City of Huntsville, Alabama; and

**WHEREAS**, said property, having been outside the boundaries of the City of Huntsville, Alabama, prior to the annexing of same to the City of Huntsville, Alabama, has never been subject to the Zoning Ordinances of the City of Huntsville, Alabama; and

**WHEREAS**, the Planning Commission of the City of Huntsville, Alabama, has given consideration to an amendment to the Zoning Ordinance, a synopsis of said amendment being as follows:

- (1) The zoning of 1.24 acres of land lying on the west side of Mohawk Road and north of Olmstead Road to Residence 1-A District.
- (2) The first publication of this resolution, this synopsis, and the ordinance hereinafter set out at length shall be in the Huntsville Times on the 30<sup>th</sup> day of January, 2022, and the second publication shall be one week thereafter on the 6<sup>th</sup> day of February, 2022, both of which publications shall be at least 15 days in advance of the date of the public hearing hereinafter referred to.

**WHEREAS**, it is the judgement and opinion of the City Council of the City of Huntsville, Alabama, that consideration should be given to the adoption of an amendment to the Zoning Ordinance of the City of Huntsville, Alabama, in accordance with said request;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, as follows:

- 1. That the City Council of the City of Huntsville, Alabama, shall meet at 5:30 p.m. on the 24<sup>th</sup> day of February, 2022, in the Council Chambers of the City of Huntsville Administration Building at 308 Fountain Circle in the City of Huntsville, Alabama, for the purpose of holding a public hearing at which time and place all persons, parties in interest and cities who desire, shall have an opportunity to be heard in opposition to or in favor of said Ordinance No. 22-\_\_\_\_, which is introduced by the City Council of the City of Huntsville on the 13<sup>th</sup> day of January, 2022, amending the Zoning Ordinance of the City of Huntsville, Alabama.
- 2. That the proposed amendment to the Zoning Ordinance of the City of Huntsville, Alabama, is substantially in words and figures as follows:

## ORDINANCE NO. <u>22-</u>

## AN ORDINANCE TO AMEND THE ZONING ORDINANCES OF THE CITY OF HUNTSVILLE, ALABAMA

The public welfare requiring it, and under authority granted by Section 11-52-78 of the 1975 Code of Alabama, **BE IT ORDAINED** by the City Council for the City of Huntsville, Alabama, as follows:

1. That the following area, on the west side of Mohawk Road and north of Olmstead Road, which area is a newly annexed area of the City of Huntsville, Madison County, Alabama, and which has not been zoned previously, shall be shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, as Residence 1-A District, in the Zoning Ordinances of the City of Huntsville, Alabama, said property being particularly described as follows:

All that part of Section 35, Township 04 South, Range 01 East of the Huntsville Meridian, in the City of Huntsville, Madison County, Alabama more particularly described as beginning at a point located at the Northeast Corner of said Section 35; thence South 50 Degrees 18 Minutes 47 Seconds West 2,485.18 feet to a point; said point is further described as the Point of True Beginning; thence from the Point of True Beginning, South 00 Degrees 59 Minutes 02 Seconds West, 11.33 feet to a point; thence South 03 Degrees 59 Minutes 52 Seconds East, 56.95 feet to a point; thence South 04 Degrees 51 Minutes 12 Seconds East, 15.06 feet to a point; thence South 09 Degrees 50 Minutes 35 Seconds East, 26.23 feet to a point; thence South 23 Degrees 14 Minutes 26 Seconds East, 59.28 feet to a point; thence South 86 Degrees 35 Minutes 49 Seconds West, 53.48 feet to a point; thence South 18 Degrees 15 Minutes 02 Seconds East, 35.83 feet to a point; thence North 88 Degrees 18 Minutes 29 Seconds West, 239.30 feet to a point; thence North 18 Degrees 14 Minutes 58 Seconds West, 68.79 feet to a point; thence North 01 Degree 13 Minutes 00 Seconds East, 135.15 feet to a point; thence South 88 Degrees 15 Minutes 14 Seconds East, 225.52 feet to a point; thence North 89 Degrees 57 Minutes 58 Seconds East, 41.69 feet back to the Point of True Beginning and containing 1.24 acres, more or less.

- 2. The boundaries of the above district as described and defined above are hereby established and shall be shown on the Official Zoning Maps of the City of Huntsville, Alabama, on file in the Planning Division of the Urban Development Department, in accordance with the various classifications herein enumerated and hereafter the regulations governing said district under the Zoning Ordinance of the City of Huntsville, Alabama, shall apply to the area so described.
  - 3. This ordinance shall take effect from and after the date of publication.
