WITNESSETH:

NOW, THEREFORE, in consideration of the mutual promises and covenants herein contained, the parties do hereby agree as follows, to-wit:

- 1. The Arts Council will provide the following services to support the Huntsville Public Art Master Plan:
 - a) Develop and manage annual work plan of public art installations supporting City of Huntsville capital projects, development partnerships and City of Huntsville creative placemaking goals.
 - b) Offer professional development support to Huntsville artists working to enter the public art arena.
 - c) Provide community engagement and education opportunities to Huntsville residents and visitors.
 - d) Maintain and annually update City of Huntsville public art inventory.
 - e) Oversee annual maintenance of City of Huntsville public art inventory and coordinate maintenance with City of Huntsville General Services.
 - f) Be expressly authorized to seek and accept financial sponsorships from philanthropic organizations, local businesses, and corporations to support the City of Huntsville Public Art Program. Documentation of the terms of the sponsorships is to be maintained on file in The Arts Council administrative office and open to review by the City of Huntsville upon request. The City has the right of approval for all sponsors.
 - g) Serve as the primary vehicle for collecting, vetting, and managing proposed public art installations throughout the City.
- 2. As consideration for the services provided by The Arts Council, the City will:
 - a) Provide project-based support for public art projects through September 30, 2026 in the annual amounts of \$250,000 (FY24), \$300,000 (FY25), and \$350,000 FY26 to support neighborhood-based public art murals, small-scale commissions, and large-scale installations in the City of Huntsville. This funding may be increased by amendment to this agreement.
 - b) Pay The Arts Council an annual staff support allowance of \$77,000 in FY24, \$162,960 in FY25, and \$172,738 in FY26, as professional services, payable in annual quarterly installments. This funding may be increased by amendment to this agreement.

The term of this Agreement commences on April 1, 2024 and continues through September 30, 2026.

This Agreement, along with all exhibits and attachments or other documents affixed hereto or referred to herein, embodies the entire agreement, intent and understanding of the City and The Arts Council and merges herein all prior and contemporaneous agreements, conditions, covenants, discussions, provisions, representations, statements, terms, warranties and understandings heretofore made between the City and The Arts Council, whether written, oral or both.
