**WHEREAS**, the City Council of the City of Huntsville, Alabama previously approved the expenditure for funds for electric general development and extension for fiscal year 2024 at a total estimated cost of \$7,400,000.00; and

WHEREAS, there has been an increased commercial and residential development and overall inflation; and

**WHEREAS,** on August 28, 2024, the City of Huntsville Electric Utility Board has approved an additional expenditure for electric general development and extension in the amount of \$3,900.000.00; and

**WHEREAS**, the estimated cost of said Purchase is in excess of \$25,000.00 and requires the consent and approval of the City Council of the City of Huntsville, Alabama; and

**WHEREAS**, the City Council of the City of Huntsville, Alabama previously approved the expenditure for distribution transformers for fiscal year 2024 at a total estimated cost of \$13,442,000.00; and

**WHEREAS**, the purchase price of distribution transformers has steadily increased due to the rising costs of materials, labor shortages, and overall inflation; and

**WHEREAS,** on August 28, 2024, the City of Huntsville Electric Utility Board has approved an additional expenditure for the purchase of distribution transformers in the amount of \$3,000,000.00; and

**WHEREAS**, the estimated cost of said Purchase is in excess of \$25,000.00 and requires the consent and approval of the City Council of the City of Huntsville, Alabama;

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Huntsville, Alabama that the additional expenditure for electric general development and extension at a total estimated cost of \$3,900,000.00 and the purchase electric distribution transformers at a total estimated cost of \$3,000,000.00 be, and the same is hereby approved and the written consent or approval of the City Council of the City of Huntsville is hereby granted to the City of Huntsville Electrics Utility Board for the expenditure of sufficient funds from the proper fund belonging to the City of Electric Utility Board for the payment of the cost thereof.

## **Distribution Transformers**

The purchase price of distribution transformers has steadily increased in recent years but rose steeply during the post-pandemic supply chain crisis. The rise in prices significantly impacted HU, as this corresponded with a period of rapid community growth. At the peak of the crisis, HU ordered as many transformers as possible for a range of suppliers. Now, many of the transformers have arrived, as have the invoices.

The FY24 approved budget amount for distribution transformers is \$13,442,000. With two months left in the fiscal year, HU has spent \$14,500,000 on distribution transformers. Our projected spending by the fiscal year end will be nearly \$16,500,000. We request an additional \$3,000,000 be added to the budget for distribution transformers for FY24.

#### **General Development and Extensions**

The FY24 Electric General Development and Extension was budgeted at \$7,400,000. Our projected spending by the fiscal year end will be nearly \$11,300,000. We request an additional \$3,900,000 to be added to the budget for General Development and Extensions for FY24.

This is externally driven by increased commercial and residential development and inflation. Developer fees will offset this amount, but the exact amount is unknown at this time.
