MODIFICATION NO. 1

THIS MODIFICATION NO. 1 IS MADE TO THE AGREEMENT entitled “Agreement Between the City of Huntsville, Alabama and Hands Across Decatur, Inc.” as approved by Resolution No. 24-265, for the use of HESG funds” as referenced above and is entered into on this the 7th day of November, 2024 by and between the City of Huntsville, Alabama (City) and Hands Across Decatur, Inc. 
