- **Section 3.** The position of Landscape Architect is hereby created and classified at a salary grade 18.
- **Section 4.** The position of Security Guard, classified at a salary grade 5, is hereby reclassified at a salary grade 6.
- Section 5. The position of Parks & Recreation Relations Officer, classified at a salary grade 15, is hereby renamed Parks & Recreation Communications Specialist, classified at a salary grade 15.
- **Section 6.** The position of Fire Technology Specialist is hereby created and classified at a salary grade 14.
- **Section 7.** The position of Fire Technology Assistant is hereby created and classified at a salary grade 12.
- **Section 8.** The position of Fire Logistics Division Manager is hereby created and classified at a salary grade 19.
- **Section 9.** The position of Fire Services Facilities Coordinator is hereby created and classified at a salary grade 13.
- **Section 10.** The position of Fire Strategic Planning Coordinator is hereby created and classified at a salary grade 15.
- **Section 11.** The position of Fire Personnel Support Coordinator is hereby created and classified at a salary grade 14.
- **Section 12.** In all other respects, Ordinance No. 89-79, as amended, shall remain in full force and effect.
