RESOLUTION NO. 24-

WHEREAS, the Planning Commission of the City of Huntsville, Alabama, has given consideration to an amendment to the Zoning Ordinance, a synopsis of said amendment being as follows:

- (1) The rezoning of certain land lying on the east side of Pulaski Pike NW and south of Bob Wade Lane from Highway Business C-4 District to Residence 2 District, and from Residence 2 District to Highway Business C-4 District.
- (2) The first publication of this resolution, this synopsis, and the ordinance hereinafter set out at length shall be in the Speakin' Out News on the 25th day of December, 2024, and the second publication shall be one week thereafter on the 1st day of January, 2025, both of which publications shall be at least 15 days in advance of the date of the public hearing hereinafter referred to.

WHEREAS, it is the judgement and opinion of the City Council of the City of Huntsville, Alabama, that consideration should be given to the adoption of an amendment to the Zoning Ordinance of the City of Huntsville, Alabama, in accordance with said request;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, as follows:

- 1. That the City Council of the City of Huntsville, Alabama, shall meet at 5:30 p.m. on the <u>23rd</u> day of <u>January</u>, 2025, in the Council Chambers of the City of Huntsville Administration Building at 305 Fountain Circle in the City of Huntsville, Alabama, for the purpose of holding a public hearing at which time and place all persons, parties in interest and cities who desire, shall have an opportunity to be heard in opposition to or in favor of said Ordinance No. 25-____, which is introduced by the City Council of the City of Huntsville on the <u>5th</u> day of <u>December</u>, 2024, amending the Zoning Ordinance of the City of Huntsville, Alabama.
- 2. That the proposed amendment to the Zoning Ordinance of the City of Huntsville, Alabama, is substantially in words and figures as follows:

ORDINANCE NO. 25-

AN ORDINANCE TO AMEND THE ZONING ORDINANCES OF THE CITY OF HUNTSVILLE, ALABAMA

The public welfare requiring it, and under authority granted by Section 11-52-78 of the 1975 Code of Alabama, **BE IT ORDAINED** by the City Council for the City of Huntsville, Alabama, as follows:

1. That the following area, land lying on the east side of Pulaski Pike NW and south of Bob Wade Lane, which area is now shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, Highway Business C-4 District, shall be shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, as Residence 2 District, in the Zoning Ordinances of the City of Huntsville, Alabama, said property being particularly described as follows:

All that part of Section 33, Township 02 South, Range 01 West of the Huntsville Meridian, in the City of Huntsville, Madison County, Alabama more particularly described as commencing at a point located at the Southwest Corner of said Section 33; thence North 30 Degrees 58 Minutes 46 Seconds East 1052.21 feet to a point; said point is further described as the Point of True Beginning; thence from the Point of True Beginning North 73 Degrees 15 Minutes 37 Seconds East 430.77 feet to a point; thence South 00 Degrees 31 Minutes 59 Seconds West 157.13 feet to a point; thence North 85 Degrees 24 Minutes 10 Seconds West 412.38 feet back to the Point of True Beginning and containing 0.80 acres more or less.

2. That the following area, land lying on the east side of Pulaski Pike NW and south of Bob Wade Lane, which area is now shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, Residence 2 District, shall be shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, as Highway Business C-4 District, in the Zoning Ordinances of the City of Huntsville, Alabama, said property being particularly described as follows:

All that part of Section 33, Township 02 South, Range 01 West of the Huntsville Meridian, in the City of Huntsville, Madison County, Alabama more particularly described as commencing at a point located at the Southwest Corner of said Section 33; thence North 00 Degrees 42 Minutes 11 Seconds East 831.39 feet to a point; said point is further described as the Point of True Beginning; thence from the Point of True Beginning North 00 Degrees 31 Minutes 28 Seconds East 125.46 feet to a point; thence South 89 Degrees 39 Minutes 06 Seconds East 19.26 feet to a point; thence South 77 Degrees 04 Minutes 19 Seconds East 41.71 feet to a point; thence South 84 Degrees 30 Minutes 32 Seconds East 472.51 feet to a point; thence South 75 Degrees 06 Minutes 20 Seconds West 153.75 feet to a point; thence South 71 Degrees 06 Minutes 36 Seconds West 35.33 feet to a point; thence South 79 Degrees 36 Minutes 30 Seconds West 35.33 feet to a point; thence South 83 Degrees 51 Minutes 27 Seconds West 35.33 feet to a point; thence South 88 Degrees 06 Minutes 22 Seconds West 35.33 feet to a point; thence South 89 Degrees 53 Minutes 07 Seconds

West 210.01 feet back to the Point of True Beginning and containing 0.97 acres more or less.

3. The boundaries of the above district as described and defined above are hereby established and shall be shown on the Official Zoning Maps of the City of Huntsville, Alabama, on file in the Planning Division of the Urban Development Department, in accordance with the various classifications herein enumerated and hereafter the regulations governing said district under the Zoning Ordinance of the City of Huntsville, Alabama, shall apply to the area so described.

4. This ordinance shall take effect from and after the date of publication.
