MEMORANDUM OF AGREEMENT

Description of Transaction:

The City of Huntsville is applying for a Department of Homeland Security Pre-Disaster Mitigation Grant under Congressionally Directed Funding, referenced as **DHS PMD Grant** (the "Grant"). The City's application is being submitted on behalf of Huntsville Hospital for Women & Children – a critical facility in Madison County. The City's application requests funding to replace an aging generator and existing parallel gear which has obsolete breakers, hardware, and software at Huntsville Hospital for Women & Children. The current equipment is unreliable due to age, and does not support all necessary functions of the hospital.

Under the grant terms, chosen projects will receive 75% reimbursement of project costs, and the remaining 25% of project costs are considered the "non-federal share." Huntsville Hospital for Women & Children has a full understanding that grant funding is restricted to 75% of the total project cost, and is committed to covering the remaining 25% non-federal share.

Should City of Huntsville's application be chosen for a grant, Huntsville Hospital for Women & Children commits to fully funding the cost of said generator (the "Project"), and will work with the City of Huntsville, which will submit receipts and project information to the grantor on behalf of Huntsville Hospital for Women & Children to receive the 75% reimbursement. The City of Huntsville will reimburse Huntsville Hospital for Women & Children in a timely manner the full amount received from the grantor of all Grant proceeds.
