WHEREAS, the Gulf Coast Regional Fugitive Task Force (GCRFTF) was among the first Regional Fugitive Task Forces to become fully operational following the Presidential Threat Protection Act of 2000; and

WHEREAS, the GCRFTF has partnership agreements with over 61 federal, state, and local agencies, including the Huntsville Police Department, and has 8 fully operational offices; and

WHEREAS, the GCRFTF has successfully apprehended over 70,800 fugitives since its inception and has made an extraordinary impact on the apprehension of the region's most dangerous and violent fugitives, making our community safer.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Huntsville, Alabama that the Mayor be, and he is hereby authorized to enter into an agreement by and between the City of Huntsville and the United States Marshals Service, on behalf of the City of Huntsville, a municipal corporation in the State of Alabama, which said agreement is substantially in words and figures similar to that certain document attached hereto and identified as "Memorandum of Understanding (MOU) between the City of Huntsville and Gulf Coast Regional Fugitive Task Force" consisting of one (1) page and the date of December 18, 2025 appearing on the first page, together with the signature of the President or President Pro Tem of the City Council, an executed copy of said document being permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama.

Reimbursement of overtime work shall be consistent with the Fair Labor Standards Act. Annual overtime for each state or local law enforcement officer is capped at the equivalent of 25% of a GS-1811-12, Step 1, of the general pay scale for the RUS. Reimbursement for all types of qualified expenses shall be contingent upon availability of funds and the submission of a proper request for reimbursement which shall be submitted monthly or quarterly on a fiscal year basis, and which provides the names of the investigators who incurred overtime for the Task Force during the quarter; the number of overtime hours incurred, the hourly regular and overtime rates in effect for each investigator.
