THIS MODIFICATION NO 3 IS MADE TO THE AGREEMENT entitled "Huntsville Housing Authority Contract for the Provision of Alternate Police Services" as referenced above and is entered into on this 13th day of October 2022, by and between the CITY OF HUNTSVILLE, ALABAMA (City) and the Huntsville Housing Authority (Authority).

WITNESSETH

WHEREAS, the parties have entered into an Agreement for the City to provide additional police services to create a drug and crime-free environment to provide for the safety and protection of the residents of the Authority's public housing developments; and

WHEREAS, the parties have previously amended the said agreement to extend the Term of the Contract; and

WHEREAS, the parties desire to further extend the Term of the Contract.

- 2. All other terms and conditions of the Agreement as amended remain unchanged and in full force and effect.
