MODIFICATION NO. 2 TO LEASE AGREEMENT

)

This Modification No. 2 to the Lease Agreement (this "Modification No. 2") is made effective as of the _____ day of May, 2023 by and between the CITY OF HUNTSVILLE, (the "City") a municipal corporation within the State of Alabama and NSH Nextco LLC (NSH), a Tennessee limited liability company.

WITNESSETH

WHEREAS, the City and NSH entered into that certain fixed Lease Agreement on July 14, 2022 (the "Lease"), which set forth the respective rights and responsibilities of the parties for the lease to NSH of Joe Davis Stadium; and

WHEREAS, the Lease was modified by the parties pursuant to Modification No. 1 on February 23, 2023; and

WHEREAS, the parties mutually desire to amend the Lease to clarify the methods of payment available to NSH.

NOW THEREFORE, in consideration of the foregoing facts and circumstances, the mutual covenants and promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by each of the parties, the parties do hereby agree to the following:

1. Section 5.03 of the Lease is deleted in its entirety and replaced with the following language:

<u>Payment by Third Parties</u>. Lessor will accept payments from third parties for the benefit of Lessee. All funds received by the City or a related City 501(c)(3) organization from said Third Parties will be credited toward any amounts owed from Lessee pursuant to the Lease. City will notify Lessee immediately upon receipt of such funds. All quarterly Base Rent installments will be adjusted accordingly.

2. All other terms and conditions of the Lease, as modified, remain unchanged and in full force and effect.
