ORDINANCE NO. 24-____

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of a utility and drainage easement; that the applicant has represented to the City of Huntsville that **Jean Management**, **LLC**, is the owner of the property across which said easement lies; that said easement, or the portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

Section 2. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easement hereinafter described, said deed being substantially in words and figures as follows, to-wit:

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, CITY OF HUNTSVILLE, ALABAMA, an Alabama municipal corporation, hereinafter referred to as "Grantor", in consideration of the sum of TEN DOLLARS (\$10.00), in hand paid to it by JEAN MANAGEMENT, LLC, AN ALABAMA LIMITED LIABILITY COMPANY, hereinafter referred to as "Grantee", and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, does hereby REMISE, RELEASE, QUITCLAIM AND CONVEY unto the said Grantee, all of the Grantor's right, title, interest and claim in and to the following described real estate situated in the City of Huntsville, County of Madison, State of Alabama, to-wit:

BEING AN EASEMENT OF LAND SITUATED IN A PORTION OF LOT 1, ACCORDING TO LOT 1 BAILEY COVE OFFICE PLAZA, PHASE 6 AS RECORDED PER PLAT BOOK 2024, PAGES 237-238 IN THE OFFICE OF THE JUDGE OF PROBATE OF MADISON COUNTY, ALABAMA, AND LYING IN A PORTION OF SECTION 21, TOWNSHIP 4 SOUTH, RANGE 1 EAST OF THE HUNTSVILLE MERIDIAN, MADISON COUNTY, ALABAMA, AND ALSO BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A 5/8 INCH REBAR CAPPED "SMITH ENGINEERING CA#00122LS" LYING ON THE SOUTHERLY RIGHT-OF-WAY LINE OF SPRING GATE LANE SOUTHEAST; THENCE LEAVING SAID SOUTHERLY RIGHT-OF-WAY LINE SOUTH 01 DEGREES 09 MINUTES 43 SECONDS WEST A DISTANCE OF 10.00 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 88 DEGREES 48 MINUTES 29 SECONDS EAST A DISTANCE OF 5.00 FEET; THENCE SOUTH 01 DEGREES 09 MINUTES 42 SECONDS EAST A DISTANCE OF 141.68 FEET; THENCE SOUTH 67 DEGREES 22 MINUTES 00 SECONDS WEST A DISTANCE OF 10.93 FEET; THENCE NORTH 01 DEGREES 09 MINUTES 42 SECONDS EAST A DISTANCE OF 146.10 FEET; SOUTH 88 DEGREES 48 MINUTES 29 SECONDS EAST A DISTANCE OF 5.00 FEET TO THE POINT OF BEGINNING.
