MODIFICATION NO. 1

This modification is made to the entitled "Agreement between the City of Huntsville, Alabama and Catholic Center of Concern.," as referenced above and is entered into on this the 10th day of April 2025 by and between the City of Huntsville, Alabama (City) and Catholic Center of Concern (Sub-recipient).

WITNESSETH

WHEREAS, the Agency has indicated a need to modify budget line items to increase salary costs, operating expenses, professional services and rent and utility assistance in order to complete the terms of ERAP Program. The Agency is a nonprofit organization duly organized to promote and assist eligible households with rent, rental arrears, utilities, utility arrears and other housing expenses services for households under the Huntsvillehousinghelp.com program; and

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

1. Effective April 10, 2025, the Use of Funds set forth in Section III, of the Agreement is modified to increase salary costs, operating expenses, professional services and rent and utility assistance in order to complete the terms of ERAP Program :
