BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, that the Mayor be, and is hereby authorized to enter into Modification No. 1 to the Agreement between the City of Huntsville and Weaver Environmental Services Company, Inc., adopted and approved on the 10th day of October, 2024, by the City Council of the City of Huntsville, Alabama by Resolution No. 24-765, as attached hereto.

BE IT FURTHER RESOLVED that the periodic contract is extended for an additional one (1) year period with services provided on an as-needed basis with up to the Not-to-Exceed (NTE) Amount of ONE MILLION ONE HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED FIFTY AND NO/100 DOLLARS (\$1,123,750.00). This extension results in the cumulative Not-to-Exceed amount funded for this contract to be TWO MILLION TWO HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$2,247,500.00). New contract expiration date: October 10, 2026. THIS IS MODIFICATION NO. 1 TO AN AGREEMENT entered in on the 10th day of October, 2024, in the amount of ONE MILLION ONE HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED FIFTY AND NO/100 DOLLARS (\$1,123,750.00), for an additional one (1) year period. The original Agreement is hereby amended by Modification No. 1 dated October 9, 2025, for the renewal of an additional one (1) year period in the same Not to Exceed (NTE) amount as the initial year of ONE MILLION ONE HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED FIFTY AND NO/100 DOLLARS (\$1,123,750.00) for the revised cumulative contract amount of TWO MILLION TWO HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$2,247,500.00), by and between the City of Huntsville, Alabama, a municipal corporation in the State of Alabama (Owner) and Weaver Environmental Services Company, Inc. (CONTRACTOR).

WITNESSETH

WHEREAS, the firm identified as the CONTRACTOR to the Agreement dated October 10th, 2024, has proposed a change to the Original Agreement. This modification delineates a change to extend the contract for an additional one (1) year period at the same Not-To-Exceed amount as the initial year of ONE MILLION ONE HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED FIFTY AND NO/100 DOLLARS (\$1,123,750.00) per Paragraph 1 and 2 on Page 2 of Attachment B of the original contract which was adopted by Resolution No. 24-765 of October 10th, 2024.

NOW THEREFORE, in consideration of the mutual covenants set forth herein, the Owner and the CONTRACTOR agree to the following modifications to the agreement:

1. Weaver Environmental Services Company, Inc. will provide for renewal of contract for an additional one (1) year with services provided on an as-needed basis with up to the initial Not-to-Exceed (NTE) Amount of ONE MILLION ONE HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED FIFTY AND NO/100 DOLLARS (\$1,123,750.00). This extension results in the cumulative Not-to-Exceed amount funded for this contract to be TWO MILLION TWO HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$2,247,500.00).

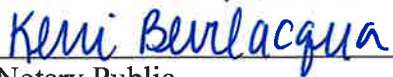
