MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF HUNTSVILLE, ALABAMA AND THE CITY OF HUNTSVILLE d/b/a HUNTSVILLE UTILITIES

STATE OF ALABAMA

COUNTY OF MADISON

MEMORANDUM OF AGREEMENT

THIS AGREEMENT, made and entered into this 12th day of October, 2023, by and between the City of Huntsville, a municipal corporation in the State of Alabama, hereinafter referred to as the "City" and the City of Huntsville d/b/a Huntsville Utilities, hereinafter referred to as "HU".

WITNESSETH:

WHEREAS, HU recently completed utility improvements on Marsheutz, Poincianna, Brandon and Rhett Streets in the City; and,

WHEREAS, it was necessary for HU's contractor to excavate areas on these public streets parallel to the curb and gutter measuring 3 feet wide and 4 feet deep in order to complete improvements on water mains; and,

WHEREAS, the City had Rogers Group, Inc. repair the street damage caused by the excavation at the rate set forth in the City's periodic bid with Rogers Group, Inc.; and.

WHEREAS, HU has agreed to reimburse the City for the cost of the repairs performed by Rogers Group, Inc.

NOW, THEREFORE, for and in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

- 1. The repairs performed on Marsheutz, Poincianna, Brandon and Rhett Streets by Rogers Group, Inc. were necessary due to the water main improvements carried out on behalf of HU.
- 2. The cost of the said repairs was \$127,724.24 determined through rates established by a competitive bid process.

- 3. The City agrees to pay \$127,724.24 to Rogers Group, Inc., and HU agrees to pay to the City the amount of \$127,724.24 as reimbursement for the said payment to Rogers Group, Inc.
- 4. HU will pay this amount to the City within thirty (30) days of the execution of this Memorandum of Agreement by both parties.
- 5. This Agreement supersedes all prior agreements, understandings, representations, warranties, requests for proposal and negotiations, if any.
