City shall have the option to renew for four additional one-year terms. Rental rate increases 3 percent for each renewal term. Property is for use by HPD. Previous lease was for five years.

MODIFICATION NO. 1 TO LEASE AGREEMENT BETWEEN WIZ KIDZ, LLC AND THE CITY OF HUNTSVILLE DATED FEBRUARY 28, 2019 AS ADOPTED AND APPROVED BY THE HUNTSVILLE CITY COUNCIL PURSUANT TO RESOLUTION NO. 19-167

MODIFICATION NO. 1 TO LEASE AGREEMENT

This Modification No. 1 to the Lease Agreement (this "Modification No. 1") is made effective as of the Ashday of March, 2024 by and between WIZ KIDZ, LLC (Lessor), an Alabama limited liability company, and the CITY OF HUNTSVILLE, ALABAMA, (Lessee) a municipal corporation within the State of Alabama (the "City").

WITNESSETH

WHEREAS, Wiz Kidz, LLC and the City of Huntsville entered into that certain Lease Agreement on February 28, 2019 (the "Lease"), with a term of five (5) years commencing on July 1, 2019 and continuing through June 30, 2024; and

WHEREAS, the parties mutually desire to extend the term of the Lease Term for an additional term of one year with the Lessee having the option to renew for four (4) additional one-year terms; and

WHEREAS, the parties desire to adjust the rental rate for the renewal term(s).

NOW THEREFORE, in consideration of the foregoing facts and circumstances, the mutual covenants and promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by each of the parties, the parties do hereby agree to the following:

- 1. The Lease is extended for an additional one (1) year term commencing on July 1, 2024 and continuing through June 30, 2025. Lessee shall have the option to renew the Lease for up to four (4) additional one-year terms (the "Renewal Terms").
- 2. The rental rate for the first one-year term shall be SEVENTEEN DOLLARS AND 00/100 (\$17.00) per square foot per year or Sixty-eight Thousand and Four Dollars (\$68,004.00). The monthly rental rate shall be Five Thousand Six hundred Sixty-six and 00/100 dollars (\$5,667.00). The rental rate shall increase by three percent (3%) each Renewal Term.
- 3. All other terms and conditions of the Lease Agreement remain unchanged and in full force and effect.
