

ORDINANCE NO. 21-

AN ORDINANCE TO AMEND THE ZONING ORDINANCES OF THE CITY OF HUNTSVILLE, ALABAMA

The public welfare requiring it, and under authority granted by Section 11-52-78 of the 1975 Code of Alabama, **BE IT ORDAINED** by the City Council for the City of Huntsville, Alabama, as follows:

1. That the following area, on the west of Little Cove Road and north of Persimmon Place, which area is a newly annexed area of the City of Huntsville, Madison County, Alabama, and which has not been zoned previously, shall be shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, as Residence 1-A District, in the Zoning Ordinances of the City of Huntsville, Alabama, said property being particularly described as follows:

All that part of Section 17, Township 04 South, Range 02 East of the Huntsville Meridian, in the City of Huntsville, Madison County, Alabama more particularly described as beginning at a point located at the Southwest Corner of said Section 17; thence North 24 Degrees 27 Minutes 19 Seconds East 2,021.54 feet to a point; said point is further described as the Point of True Beginning; thence North 51 Degrees 51 Minutes 38 Seconds West 93.57 feet to a point; thence North 53 Degrees 33 Minutes 13 Seconds West 183.23 feet to a point; thence North 59 Degrees 23 Minutes 7 Seconds West 87.95 feet to a point; thence North 49 Degrees 40 Minutes 2 Seconds East 323 feet to a point; thence North 41 Degrees 58 Minutes 28 Seconds East 236.5 feet to a point; thence South 27 Degrees 25 Minutes 15 Seconds East 245.84 feet to a point; thence South 42 Degrees 35 Minutes 54 Seconds West 281.82 feet to a point; thence South 58 Degrees 0 Minutes 28 Seconds East 93.74 feet to a point; thence South 38 Degrees 57 Minutes 47 Seconds West 84 feet to a point; thence South 45 Degrees 36 Minutes 38 Seconds West 79.57 feet the Point of True Beginning and containing 3.06 acres more or less.

2. The boundaries of the above district as described and defined above are hereby established and shall be shown on the Official Zoning Maps of the City of Huntsville, Alabama, on file in the Planning Division of the Urban Development Department, in accordance with the various classifications herein enumerated and hereafter the regulations governing said district under the Zoning Ordinance of the City of Huntsville, Alabama, shall apply to the area so described.

3. This ordinance shall take effect from and after the date of publication.
