NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Huntsville, Alabama, that the City Attorney's Office is hereby authorized, requested, and directed to seek a forfeiture of the surety bond issued by Western Surety Company; and

BE IT FURTHER RESOLVED by the City Council of the City of Huntsville, Alabama, that the Mayor, upon payment by Western Surety Company and in accordance with its bond, is hereby authorized, requested, and directed to execute a release and assignment agreement substantially in words and figures as Attachment "A", an executed copy of said document being permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama.

KNOW ALL MEN BY THESE PRESENTS that the undersigned, for the sole consideration of THREE THOUSAND SIX AND 37/100 DOLLARS (\$3,006.37) to be paid by Western Surety Company from the bond of Case No. 393 (Bond Number 63662071), to the City of Huntsville, Alabama, releases and discharges Western Surety Company from the obligation of the bond to the extent of THREE THOUSAND SIX AND 37/100 DOLLARS (\$3,006.37) for the taxing period of September 2021 through October 2021 and interest through July 2022.

The City of Huntsville, Alabama, retains any claim it may have against Case No. 393 for delinquent or deficient taxes or license fees greater than the amount of THREE THOUSAND SIX AND 37/100 DOLLARS (\$3,006.37) received from Western Surety Company for the taxing period of September 2021 through October 2021 and interest through July 2022.
