BE IT FURTHER ORDAINED that the Mayor and City Clerk be, and they hereby are, authorized and directed to dispose of the Furnishings owned by the City of Huntsville, Alabama, by selling such property via auction, Fowler Auction and Real Estate Service, Inc. All such property shall be sold to the highest bidder. The Mayor and City Clerk be, and they hereby are, authorized and directed to execute and attest, respectively, for and on behalf of the City of Huntsville; and signed by the City Clerk of the City of Huntsville, conveyance of the title to the personal property, when applicable. All proceeds of which will be deposited into the City of Huntsville General Funds account. Said documents shall be permanently kept on file in the Office of the City Clerk.
