RESOLUTION NO. 23-

WHEREAS, the City Council of the City of Huntsville, Alabama adopted Resolution 23-68 (“Resolution”) on January 26, 2023 authorizing the Mayor to make application to the United States Department of Transportation, Federal Transit Administration (“FTA”) to request to enter the Project Development phase of the Capital Investment Grants- Small Starts program for the University-Medical Bus Rapid Transit (“University-Medical BRT”) project;

WHEREAS, the City of Huntsville, in its application to the FTA attached to the Resolution, committed a total of \$3.5 million in funds from the 2014 Capital Improvement Plan (“CIP”) in Fiscal Years 2024 and 2025 to be specifically used for FTA Project Development activities to support the University-Medical BRT project;

WHEREAS, the CIP was established in Ordinance 13-959 and last amended as Resolution 22-782 by the Council to improve the City’s infrastructure, and the University-Medical BRT project would be consistent with other projects in the CIP;

WHEREAS, the City of Huntsville, subsequent to FTA approval to enter Project Development, will advance a portion of the committed funds in Fiscal Year 2023 to expedite the University-Medical BRT project and show the City’s intent to FTA to advance the project;

BE IT RESOLVED by the City Council of Huntsville, Alabama, that the CITY OF HUNTSVILLE 2014 CAPITAL IMPROVEMENT PLAN, 2023-2032, adopted and approved on September 22, 2022, is hereby amended as follows:

\$100,000 for Project Development of the University-Medical Bus Rapid Transit project in Fiscal Year 2023;

\$1,650,000 for Project Development of the University-Medical Bus Rapid Transit project in Fiscal Year 2024;

\$1,750,000 for Project Development of the University-Medical Bus Rapid Transit project in Fiscal Year 2025.
