BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, that Budget Ordinance No. 23-762, adopted and approved on September 28, 2023, is hereby amended as follows:

In the GENERAL FUND:

Increase the transfer appropriation to the Sanitation Fund by \$67,067.74 for personnel expenses funded by a decrease in the Public Works department personnel appropriation.

Increase the transfer appropriation to the Sanitation Fund by \$228,227.33 for personnel expenses funded by a decrease in the Fleet Services department personnel appropriation.

Increase the Administration department operating appropriation in the total amount of \$75,000.00 for unexpected increased costs in goods and services funded from fund balance.

In the SANITATION FUND:

Increase the Public Works department personnel appropriation by \$67,067.74 funded with a transfer from the General Fund.

Increase the Public Works department personnel appropriation by \$228,227.33 funded with a transfer from the General Fund.
