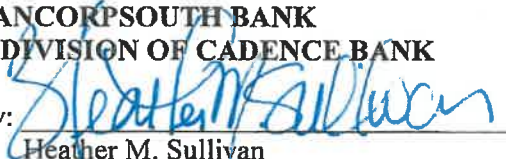
Gentlemen:
