Modification No. 1 to Agreement
Between the City of Huntsville, Alabama and
the AXON Enterprise, Inc. pursuant to
Resolution 24-1933

MODIFICATION NO. 1 TO AGREEMENT FOR POLICE OFFICER SAFETY
EQUIPMENT, SOFTWARE PROGRAMS, ETC.

This Modification No. 1 to Agreement for police officer safety equipment, software programs, etc. (this "Modification") is made and entered into on the 9th day of July, 2026, by and between the **City of Huntsville**, a municipal corporation in the State of Alabama, hereinafter referred to as the "City," and **AXON Enterprise, Inc.**, hereinafter referred to as "AXON".

WITNESSETH:

WHEREAS, the City and AXON entered into an agreement (the "Agreement") for AXON to provide police officer safety equipment, software programs, etc. on October 10, 2024 pursuant to Resolution No. 24-1933; and

WHEREAS, additional police officer safety equipment and software programs, licenses, etc. were required beginning in Year 2 of the agreement to meet the City's police and public safety needs; and

WHEREAS, the parties desire to increase the amount of funds allocated to provide funding to satisfy the outstanding amount owed for previously purchased additional police officer safety equipment and software programs from AXON to meet the City's needs; and

WHEREAS, the additional funds to be allocated to this modification are currently budgeted, allocated and available for public safety needs during the current fiscal year.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

1. The agreement originally adopted pursuant to Resolution No. 24-1933 shall be amended to include an additional Annual Payment 2 and shall be used to pay for previously purchased officer safety plan equipment, software programs, licensing, etc. in an amount not to exceed \$69, 266.73 as reflected on AXON invoices INUS421675 and INUS42173.
2. The additional Annual Payment 2, in an amount not to exceed \$69,266.73 in the second year of the 10 year agreement, is necessary to meet the City's public safety and law enforcement needs.

The additional Annual Payment 2 of the agreement shall be reflected in the portion of the original agreement called Quote Summary that begins on or about page 46 of the complete 87 page file approved pursuant to Res. 24-1933, and said additional Annual Payment 2 shall increase the overall total of all Annual Payments 2 set forth in the Invoice Plan by an amount not to exceed \$69,266.73.
4. All other terms of the Agreement remain unchanged and in full force and effect.
