

RESOLUTION NO. 24-_____

WHEREAS, the Manager of Community Development of the City of Huntsville, Alabama ("Director") has reported in a Report and Affidavit, a copy of which is attached hereto and incorporated herein by reference, that upon and/or in front of the property situated at 2203 First St SW, in Huntsville, Alabama, there exists certain conditions as those enumerated in Acts 1971, Reg. Sess., No. 71-1320, p. 2269, §2, which constitutes a public nuisance; and

WHEREAS, the Report and Affidavit of the Manager proves to the satisfaction of the City Council that the conditions that exist upon and/or in front of the referenced property constitute a public nuisance in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Huntsville, Alabama ("City Council") as follows:

1. That, in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269, the conditions as described in the Manager's Report and Affidavit existing upon and/or in front of the property at 2203 FIRST ST SW, more particularly described as follows wit: LOT 12 BLK 175 LOWE CORPORATION ADDITION, are found and hereby declared to be a public nuisance, which must be abated by the removal of said public nuisance.
2. That a meeting of the City Council shall be held at 5:30 pm, on 7/11/2024, in the City Council Chambers in the Municipal Building of the City of Huntsville, Alabama, in order to hear and consider all objections or protests, if any, to the proposed removal of said nuisance.
3. The Manager is hereby appointed to cause to be conspicuously posted in front of the property on which or in front of which the aforesaid nuisance exists, at not more than 100 feet in distance apart, but not less than two in all, notices headed, "Notice to Remove Public Nuisance", such heading to be in words not less than 1 inch in height and substantially in the following form:

NOTICE TO REMOVE PUBLIC NUISANCE

Notice is hereby given that on the 27th day of June, 2024, the City Council of the City of Huntsville, Alabama, passed a resolution declaring that a public nuisance exists upon or in front of the property at 2203 First St SW in said City of Huntsville, Alabama, and more particularly described in said resolution, and that the same constitutes a public nuisance, which must be abated by the removal of said public nuisance, otherwise they will be removed and the nuisance will be abated by the municipal authorities, in which case the cost of such removal shall be assessed upon the lots and lands from which and/or in front of which such public nuisance is removed, and such cost will constitute a lien upon such lots or lands until paid. Reference is hereby made to said resolution for other particulars.



In addition, Scott Erwin, Manager of Community Development, is hereby ordered to mail a copy of said notice to the owner(s) of the property at least five days before the meeting at which objections will be heard, such notice to be mailed to the person last assessing the property for taxes according to the records of the Madison County Tax Assessor as well as to the current owner(s) of record according to the Madison County Probate Records if different than the owner(s) last assessed.

Before me, the undersigned, a notary in and for said County in said State, personally appeared Scott Erwin, who, after being by me duly sworn, deposes and says on oath as follows:

1. My name is Scott Erwin. My business address is 120 East Holmes Ave., Yarbrough Office Bldg. / 2nd Floor, Huntsville, Alabama 35801. I am over the age of nineteen (19) years and am competent to make this Affidavit. I have personal knowledge of the matters set out herein.

2. My current title is Manager of the Community Development Division of the City of Huntsville, Alabama ("City").

3. Upon and/or in front of the following described property within the city limits of Huntsville:

2203 FIRST ST SW more particularly described as follows to-wit: LOT 12 BLK 175 LOWE CORPORATION ADDITION,

I have found to exist, as of May 6th, 2024, a blue Hyundai, tag no. 1AOYN45 (AL 05 23), tire(s) flat, not in road operable condition, located in front yard.

Tan GMC Yukon, tire(s) flat, not in road operable condition, located in front yard.

Gold Honda Odyssey van, tire(s) flat, not in road operable condition, located in front yard.

Grey Chevrolet Camaro, engine in disrepair, tire(s) flat, not in road operable condition, located on driveway.

Black GMC truck, tag no. 47C2V76 (AL 06 22), tire flat, not in road operable condition, located on driveway.

Tan GMC Yukon, tire(s) flat, not in road operable condition, located on driveway.

White Ford Travel Master, tire(s) flat, not in road operable condition, located in rear yard.

Tan Chevrolet Tahoe, tire(s) flat, not in road operable condition, located in rear yard.

White Chevrolet truck, front end damaged, wheel missing, not in road operable condition, located in rear yard.

Grey GMC truck, engine in disrepair, not in road operable condition, located in rear yard.

Tan GMC truck, tag no. 50JH630 (AL 04 22), engine in disrepair, not in road operable condition, located in rear yard.

Red Chevrolet truck, wheel missing, not in road operable condition, located in rear yard.

Blue Chevrolet trailer, tire flat, not in road operable condition, located in rear yard.

Auto tires, auto wheels, scrap wood, scrap metal, auto parts, auto jacks, auto transmissions, wood pallets, television, plastic containers filled with items, interior furniture, exercise equipment, plastic bags filled with items, pillows, air filter, shop vacuums, auto batteries, plastic pipes, dishware, cooking utensils, clothing items, metal cans, microwave, cardboard boxes filled with items, lawnmowers in disrepair, coolers, power tools, vinyl siding, concrete mixers, and other debris located in front yard, in rear yard, on driveway, and on front porch.. As a result, I have determined that the stated conditions constitute a public nuisance. (See attached hereto and incorporated herein by reference photographs of the subject property taken on May 6th, 2024, which fairly and accurately shows how the property appeared on said date.)

4. It is my recommendation that a public nuisance be declared to exist upon and/or in front of said property.

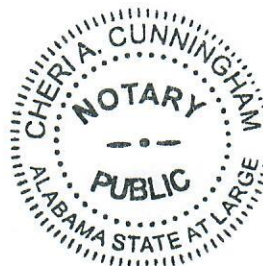

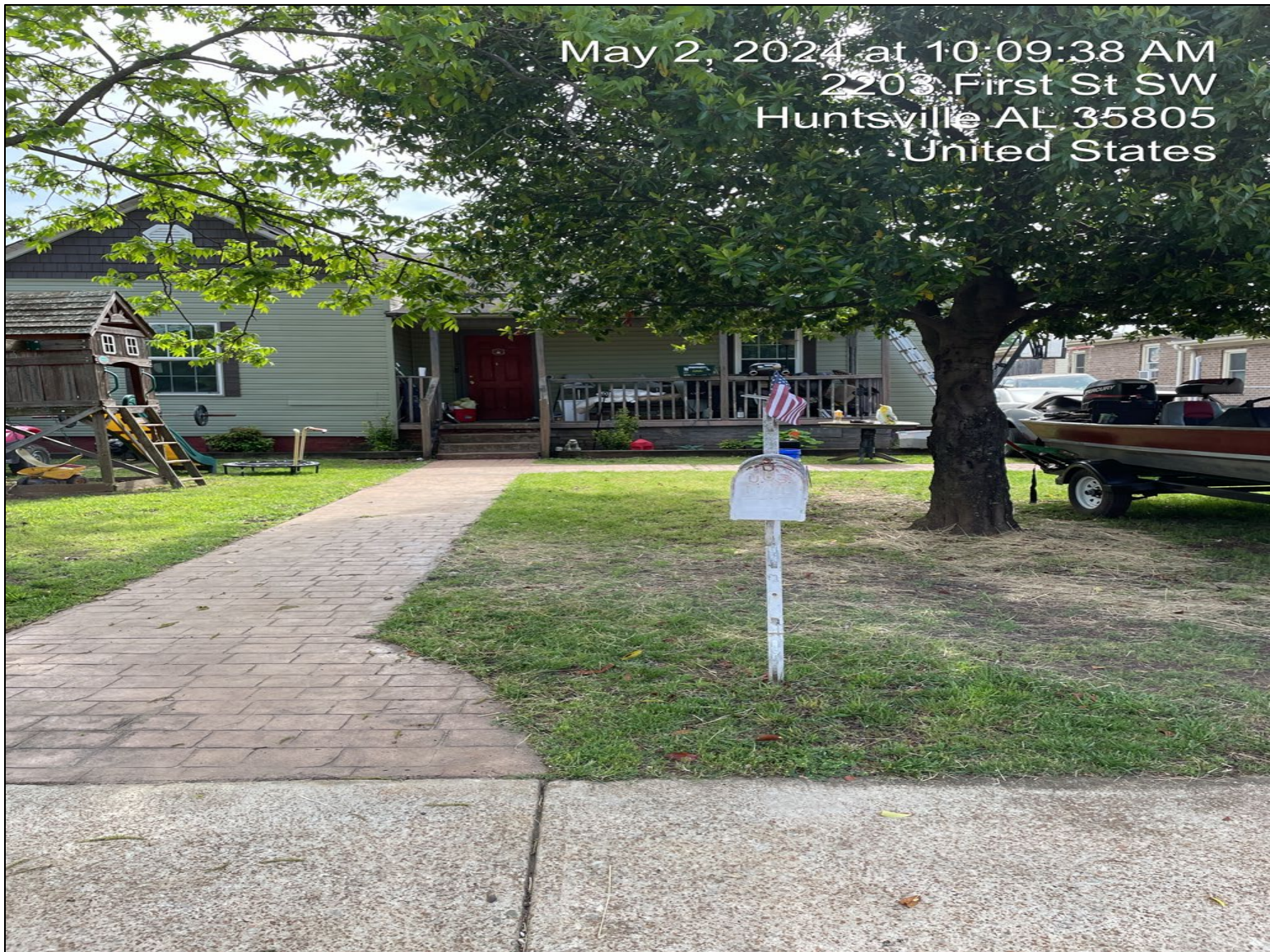
