WHEREAS, Scott Lighting Supply Company, Inc. was acquired by Redstone Electric Supply Company, LLC on June 1, 2026; and

WHEREAS, Scott Lighting Supply Company, Inc. desires to assign Electrical Items contract #28-2024-14 to Redstone Electric Supply Company, LLC; and

WHEREAS, the City hereby consents to Scott Lighting Supply Company, Inc. assignment of its rights and obligations under the contract to Redstone Electric Supply Company, LLC; and

CONTRACT ASSIGNMENT AGREEMENT

This Assignment of Contract agreement is made and entered into on the 9th day of July 2026, by and between the **CITY OF HUNTSVILLE, ALABAMA**, a municipal corporation in the State of Alabama, hereinafter referred to as the "City," and **SCOTT LIGHTING SUPPLY COMPANY, INC.**, an Alabama corporation, hereinafter referred to as "Scott Lighting" and **REDSTONE ELECTRIC SUPPLY COMPANY, LLC** an Alabama limited liability corporation, hereinafter referred to as "Redstone Electric".

WITNESSETH:

WHEREAS, pursuant to Resolution No. 26-143 the City awarded the Electrical Items contract #28-2026-14 to Scott Lighting; and

WHEREAS, this contract is in its third and final term which is set to expire on March 13, 2027; and

WHEREAS, the General Services Department was notified on June 8, 2026, by Scott Lighting that they were acquired by Redstone Electric on June 1, 2026; and

WHEREAS, Scott Lighting desires to assign contract 28-2024-14 to Redstone Electric and waives its rights conveyed to it under the terms of said contract;

WHEREAS, the City desires to consent to the assumption of the contract by Redstone Electric conditioned upon Redstone Electric assuming Scott Lighting obligations under the contract; and

WHEREAS, Redstone Electric agrees to adhere to the terms and conditions, pricing structure, specifications, and scope of services as outlined in said contract.

NOW THEREFORE, in consideration of mutual promises and covenants contained herein for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify contract 28-2024-14 as follows:

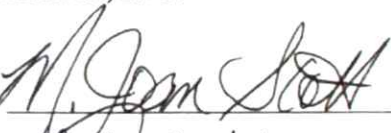
1. The City hereby consents to Scott Lighting assignment of its rights and obligations under the contracts to Redstone Electric upon completion of the acquisition.
2. Redstone Electric hereby agrees to assume Scott Lighting obligations under the contracts, including but not limited to all insurance requirements and contract pricing structure.
3. Redstone Electric shall provide the City of Huntsville's Procurement Services Division with a current certificate of insurance evidencing insurance cover, City

of Huntsville Report of Ownership, City of Huntsville Bidder Information and Acknowledgement form, City of Huntsville Business License, E-Verify Memorandum of Understanding, and proof of registration with Alabama Secretary of State as required under the contract.

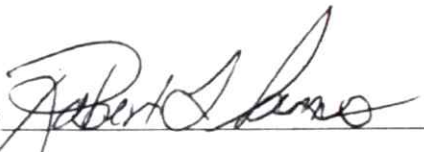

This Agreement may be executed in one or more counterparts, and each counterpart shall for all purposes, be deemed an original, but all such counterparts shall together constitute but one and the same instrument.

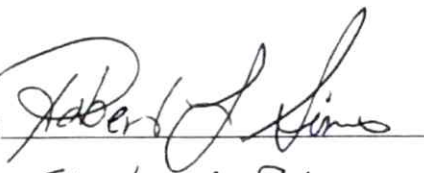
