# ORDINANCE NO. 25-\_\_\_

**BE IT ORDAINED** by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of utility and drainage easement; that the applicants have represented to the City of Huntsville that Clint Levinson and wife, Melanie N. Levinson, are the owners of the property across which said easement lies; that said easement, or the portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

**Section 2**. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easement hereinafter described, said deed being substantially in words and figures as follows, to-wit:

KNOW ALL MEN BY THESE PRESENTS, that the CITY OF HUNTSVILLE, a municipal corporation, hereinafter referred to as Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) in hand paid, the receipt whereof is hereby acknowledged, as well as other good and valuable consideration, by CLINT LEVINSON and wife, MELANIE N. LEVINSON, hereinafter referred to as Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, does hereby remise, release, quitclaim and convey unto the said Grantees, all of its right, title, interest, and claim in and to the easements located upon the following described real estate situated in the County of Madison, State of Alabama, to-wit:

See attached EXHIBIT "A," which is hereby incorporated herein.

TO HAVE AND TO HOLD the same unto the said Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to their heirs and assigns of such survivor forever.

All that part of Lot 20-A of the "RESUBDIVISION OF TRACT 20 GREEN MOUNTAIN AUCTION PROPERTY (P.B. 33, PG. 1-26) as recorded in the Office of the Judge of Probate of Madison County, Alabama in document number 2020-00013580. Said lot also being located in the Northeast Quarter of Section 16, Township 5 South, Range 1 East of the Huntsville Meridian, Madison County, Alabama. Particularly described as commencing at the Northeast corner of said Lot 20-A, being on the West right of way margin of Riverview Drive; Thence leaving said road and along the North boundary of said Lot 20-A, North 88 degrees 58 minutes 28 seconds West 10.45 feet to the Point of Beginning of the herein described tract.
