ORDINANCE NO. 25-

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. 

A tract of land lying in part of Lot 1, Max Luther Commercial Park, Phase 2, Instrument No. 2019-00077964, Madison County, Alabama, and being more particularly described as follows: **COMMENCE** at a Capped Iron Pin Found (Illegible), being the Northeast corner of said Lot 1; thence, along the East line of said Lot 1, South 31°48'28" West, 10.00 feet to the **POINT OF BEGINNING** of the herein described tract; thence, along the East line of said Lot 1, South 31°48'28" West, 130.11 feet; thence North 58°11"36" West, 10.00 feet; thence North 31°48'28" East, 129.91 feet; thence, along a curve to the right having a Chord Bearing and Distance of South 59°19'17" East, 10.00 feet and a Radius of 336.47 feet, for an Arc Length of 10.00 feet to the **POINT OF BEGINNING** of the tract of land hereby described, said tract of land contains 0.03 acres ± and is subject to any and all easements or restrictions of record or unrecorded affecting said property.
