MODIFICATION NO. 1

THIS MODIFICATION NO. 1 IS MADE TO THE AGREEMENT entitled "Agreement Between the City of Huntsville, Alabama and AshaKiran, Inc. as approved by Resolution No. 23-184, for the use of HESG funds" as referenced above and is entered into on this the <u>22nd</u> day of <u>February</u>, <u>2024</u> by and between the City of Huntsville, Alabama (City) and AshaKiran, Inc.
