## Amendment No. A1

This Amendment No. A1 to the Meltwater Services (hereinafter "Amendment") is an amendment to the agreement entered into on Aug 24, 2023 between Meltwater News US Inc. (hereinafter "Meltwater") and City of Huntsville (hereinafter "Customer"), as amended, for the provision of Meltwater Services (hereinafter the "Agreement").

The Parties wish to amend the Agreement as follows:

The Agreement for access to Meltwater Services shall be extended until Sep 30, 2025.

The fees due by Customer for the Meltwater Services for the period Oct 01, 2024 through Sep 30, 2025 shall be (amount excludes sales tax) USD 13100.00.

### Additional Provisions:

- Notwithstanding anything to the contrary in this Agreement, Customer shall pay all invoices within 30 days of the date of invoice.
- Notwithstanding anything to the contrary in this Agreement, Customer will pay all invoices in accordance with the following schedule: Invoice 1 in the amount of 13100.00 USD due on or before Oct 31, 2024 ;

Except as set forth in this Amendment No. A1, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is a conflict between this amendment and the Agreement or any earlier amendment, the terms of this Amendment shall prevail.
