BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, that the Mayor be, and is hereby authorized to enter into Modification No. 2 to the Agreement between the City of Huntsville, Alabama and Rogers Group, Inc., adopted and approved on the 7th day of December, 2023, by the City Council of the City of Huntsville, Alabama by Resolution No. 23-1002, as attached hereto.

BE IT FURTHER RESOLVED that the periodic contract is extended for an additional one (1) year period with services provided on an as-needed basis with up to the Not-to-Exceed (NTE) Amount of TWO MILLION TWO HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED NINETY-ONE AND .64/100 DOLLARS (\$2,261,691.64). This extension results in the cumulative Not-to-Exceed amount funded for this contract to be SIX MILLION SEVEN HUNDRED EIGHTY-FIVE THOUSAND SEVENTY-FOUR AND .92/100 DOLLARS (\$6,785,074.92). New contract expiration date: December 7, 2026. Agreement is substantially in words and figures similar to that document attached hereto and identified as "Modification No. 2 to the Agreement between the City of Huntsville, Alabama and Rogers Group, Inc., for Periodic Bid for Drainage Projects-2024, Project No. 71-24-RD01," consisting of a total of four (4) pages including Exhibit "A" and the date of November 6, 2025 appearing on the margin of the first page, together with the signature of the President or President Pro Tem of the City Council, and an executed copy of said document being permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama.

THIS IS MODIFICATION NO. 2 TO AN AGREEMENT entered in on the 7th day of December, 2023, in the amount of TWO MILLION TWO HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED NINETY-ONE AND .64/100 DOLLARS (\$2,261,691.64) and amended on 21st day of November 2024, in the amount TWO MILLION TWO HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED NINETY-ONE AND .64/100 DOLLARS (\$2,261,691.64) for the revised contract amount of FOUR MILLION FIVE HUNDRED TWENTY-THREE THOUSAND THREE HUNDRED EIGHTY-THREE AND .28/100 DOLLARS (\$4,523,383.28). The original Agreement is hereby amended by Modification No. 2 dated November 6, 2025, for the renewal of an additional one (1) year period in the same cumulative Not-to-Exceed (NTE) amount as the initial year of TWO MILLION TWO HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED NINETY-ONE AND .64/100 DOLLARS (\$2,261,691.64) for the revised contract amount of SIX MILLION SEVEN HUNDRED EIGHTY-FIVE THOUSAND SEVENTY-FOUR AND .92/100 DOLLARS (\$6,785,074.92), by and between the City of Huntsville, a municipal corporation in the State of Alabama (Owner) and ROGERS GROUP, INC., (CONTRACTOR).

WITNESSETH

WHEREAS, the firm identified as the CONTRACTOR to the Agreement dated December 7, 2023, has proposed a change to the Original Agreement. This modification delineates a change to extend the contract for an additional one (1) year period at the same Not-to-Exceed (NTE) amount as the initial year of TWO MILLION TWO HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED NINETY-ONE AND .64/100 DOLLARS (\$2,261,691.64) per Paragraph 5 on Page 1 of Attachment B of the Original Contract which was adopted by Resolution No. 23-1002 of December 7, 2023.

NOW THEREFORE, in consideration of the mutual covenants set forth herein, the Owner and the CONTRACTOR agree to the following modifications to the agreement:

1. Rogers Group, Inc., will provide for renewal of contract for an additional one (1) year with services provided on an as-needed basis with up to the Not-to-Exceed (NTE) amount of TWO MILLION TWO HUNDRED SIXTY-ONE THOUSAND SIX HUNDRED NINETY-ONE AND .64/100 DOLLARS (\$2,261,691.64). This extension results in the cumulative Not-to-Exceed amount funded for this contract to be SIX MILLION SEVEN HUNDRED EIGHTY-FIVE THOUSAND SEVENTY-FOUR AND .92/100 DOLLARS (\$6,785,074.92). New contract expiration date is December 7, 2026.
