ORDINANCE NO. 23-___

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of utility and drainage easement; that the applicant has represented to the City of Huntsville that **Low Fat Subs, Inc.**, is the owner of the property across which said easement lies; that said easement, or the portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

Section 2. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easement hereinafter described, said deed being substantially in words and figures as follows, to-wit:

KNOW ALL MEN BY THESE PRESENTS, that the undersigned CITY OF HUNTSVILLE, an Alabama municipal corporation, hereinafter referred to as Grantor, in consideration of the sum of Ten Dollars (\$10.00) in hand paid by LOW FAT SUBS, INC. hereinafter referred to as Grantee, and other good and valuable considerations, the receipt and sufficiency whereof is hereby acknowledged, does hereby remise, release, quitclaim, and convey unto the Grantee, all of the Grantor's right, title, interest and claim in and to the following described real estate situated in the City of Huntsville, County of Madison, State of Alabama, to-wit:

BEING A TRACT OF LAND SITUATED IN A PORTION OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 7, TOWNSHIP 4 SOUTH, RANGE 1 WEST OF THE HUNTSVILLE MERIDIAN, MADISON COUNTY, ALABAMA, AND BEING A PORTION OF LOTS 1-A AND 1-B OF THE RESUBDIVISION OF LOT 1, BLOCK 1 OF THE RESUBDIVISION OF LOT 1, BLOCK 1 AND LOT 1, BLOCK 2 EXCHANGE CENTER AS RECORDED IN PLAT BOOK 21, PAGE 80 IN THE OFFICE OF THE JUDGE OF PROBATE OF MADISON COUNTY, ALABAMA, AND ALSO BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT A 5/8 INCH REBAR ON THE SOUTHERLY RIGHT-OF-WAY OF OLD MADISON PIKE AND ALSO BEING THE NORTHWEST CORNER OF SAID LOT 1-A; THENCE LEAVING SAID SOUTHERLY RIGHT-OF-WAY SOUTH 00 DEGREES 57 MINUTES 16 SECONDS WEST ALONG THE WEST LINE OF SAID LOT 1-A A DISTANCE OF 10.00 FEET TO THE POINT OF BEGINNING OF THE HEREIN DESCRIBED TRACT:

THENCE LEAVING SAID WEST LINE SOUTH 88 DEGREES 57 MINUTES 24 SECONDS EAST A DISTANCE OF 5.00 FEET; THENCE SOUTH 00 DEGREES 57 MINUTES 16 SECONDS WEST A DISTANCE OF 211.61 FEET; THENCE NORTH 54 DEGREES 43 MINUTES 51 SECONDS WEST A DISTANCE OF 7.65 FEET; THENCE SOUTH 35 DEGREES 11 MINUTES 48 SECONDS WEST A DISTANCE OF 6.55 FEET; THENCE NORTH 00 DEGREES 57 MINUTES 16 SECONDS EAST A DISTANCE OF 212.73 FEET; THENCE SOUTH 88 DEGREES 57 MINUTES 12 SECONDS EAST A DISTANCE OF 5.00 FEET TO THE POINT OF BEGINNING.
