#### ORDINANCE NO. 24-

**BE IT ORDAINED** by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of a portion of a utility and drainage easement; that the applicant has represented to the City of Huntsville that 7413 Opportunity, LLC, is the owner of the property across which said easement lies; that said easement, or the portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

**Section 2**. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easement hereinafter described, said deed being substantially in words and figures as follows, to-wit:

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Ten Dollars (\$10), and other good and valuable considerations, cash to it in hand paid by 7413 OPPORTUNITY, LLC, an Alabama limited liability company, hereinafter referred to as grantee, the receipt of which is hereby acknowledged, the undersigned CITY OF HUNTSVILLE, a municipal corporation duly created organized and existing under and by virtue of the laws of the State of Alabama, hereinafter referred to as grantor, does hereby remise, release, quitclaim and convey unto said grantee, all of its rights, title and interest in and to the following described lot or parcel of land lying and being in the County of Madison, State of Alabama, to-wit:

COMMENCING AT A 5/8 INCH REBAR MARKING THE SOUTHEAST CORNER OF LOT 1 OF THE NORTH HUNTSVILLE INDUSTRIAL PARK PHASE 14 AND LOCATED ON THE WEST RIGHT OF WAY OF OPPORTUNITY BOULEVARD IN SECTION 28, TOWNSHIP 2 SOUTH, RANGE 1 WEST OF THE HUNTSVILLE MERIDIAN, MADISON COUNTY, ALABAMA, THEN LEAVING SAID RIGHT OF WAY AND ALONG THE SOUTH LINE OF SAID LOT 1, NORTH 83 DEGREES 00 MINUTES 26 SECONDS WEST, 379.15 FEET; THEN LEAVING SAID SOUTH LINE, NORTH 18 DEGREES 14 MINUTES 39 SECONDS EAST, 20.39 FEET TO THE POINT OF BEGINNING,

THEN FROM THE POINT OF BEGINNING, NORTH 83 DEGREES 00 MINUTES 26 SECONDS WEST, 20.39 FEET TO A POINT; THEN NORTH 18 DEGREES 15 MINUTES 32 SECONDS EAST, 299.53 FEET TO A POINT; THEN SOUTH 73 DEGREES 12 MINUTES 16 SECONDS EAST, 40.01 FEET TO A POINT; THEN SOUTH 18 DEGREES 15 MINUTES 32 SECONDS WEST, 292.58 FEET TO A POINT; THEN NORTH 83 DEGREES 00 MINUTES 26 SECONDS WEST, 20.39 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.27 ACRES MORE OR LESS.
