THIS MODIFICATION TO AN AGREEMENT is entered into on this the **5th** day of **December**, **2024** by and between the City of Huntsville, Alabama (Owner) and Bostick Landscape Architects as adopted by Resolution 24-151 on March 14, 2024. The City of Huntsville does hereby modify the contract to continue providing Architectural services for the Big Spring Park Expansion.

WHEREAS, at the time of hire, the scope of work for the Big Spring Park Expansion was to include preliminary and final designs of an upper plaza with pavilion, lower plaza, sidewalk to connect plazas to Church Street, lighting and electrical, civil engineering, landscape and irrigation for the space defined.

WHEREAS, the scope of work for design services listed in Attachment "A" of the Agreement Between the City of Huntsville, Alabama, and Bostick Landscape Architects dated March 14, 2024, as adopted by Resolution No 24-151 is hereby to include additional services listed in the attached proposal dated October 31, 2024, from Bostick Landscape Architects to include the Fountain Consultant and structural, electrical and mechanical engineering design services for the restroom building.

THEREFORE, the previously established Not to Exceed amount of Two Hundred Seventy Thousand Dollars and No/100s (\$270,000.00) for these professional services is hereby increased by the amount of Two Hundred Thousand Dollars and No/100s (\$200,000.00) thereby modifying the Not To Exceed Amount to be Four Hundred Seventy Thousand Dollars and No/100s (\$470,000.00).

RE: Big Springs Park East Addition

Dear Chris.

Thank you for the opportunity to submit this proposal to you for the design and construction drawings of the Big Springs Park east addition in Huntsville, Alabama. I am pleased to submit this outline for plaza, structure, terraces, lighting, grading and utilities, landscape, irrigation and repair design to sidewalks in the current east park.

This proposal includes using the BLA conceptual master plans of the space dated April 4, 2022 as the basis of the design.

This proposal includes the preliminary and final designs of the following; an upper plaza with a pavilion, a lower plaza, sidewalks to connect plazas to Church Street, lighting and electrical, civil engineering, landscape and irrigation for the space defined in the April drawing. This proposal will provide the project manual as well as construction administration for the project.

Bostick Landscape Architects (BLA) proposes the following approach and scope of services:

SCOPE OF SERVICES

I. Base Information and Civil Drawings

BLA will subcontract with Schoel Engineering for all survey and civil engineering work for the project.

A. The BLA team will use a cad survey provided by Schoel Engineering once the building has been removed as the basis for design. This survey will include features that may remain after site demolition as well as all topography for the areas as part of this project from the edge of the AT&T building, to the demolition fence limits in Big Springs Park East, from Fountain Circle back of curb to the south side of Church Street. Plans will be prepared at the appropriate scale from the survey information provided.

II. Preliminary Design Development Plans

A. Utilizing the base information, BLA will create a layout of the site with plazas, walks and other amenities further defined from the Conceptual drawing.



III. Preliminary Layout and Grading Plans

- A. From the above design development plan, BLA will develop a preliminary layout plan for review of the park space. The following items will be addressed as part of this preliminary layout:
 - 1. Dimensions of the amenities, sidewalks pavilions, walkways, raised table tops and median across Church Street as well as other items defined in the master plan.
 - 2. Develop a preliminary landscape and irrigation scheme(s) based off the master plan for the site as well as the expressed needs of the park from previous city meetings.

IV. Final Layout, Grading and Utility Plans

- A. Final Proposed Layout and Grading Plans.
 - Upon the city's review, comments and acceptance of the Preliminary Plans, the design team
 will prepare final construction documents for the areas outlined above incorporating these
 items and comments. The final plans will consist of dimension plans to properly lay out the
 sidewalks, median and table top, plazas, pavilion, walls steps curb and gutter and any other
 pertinent dimensions for a buildable set of plans.
 - 2. The design team will provide Final grading plans which will illustrate areas for soil renovation and addition, final spot elevations and contours as well as all drainage needed.
 - 3. The design team will provide Final utility drawings for the site coordinating with utility companies for sanitary sewer, power, water, gas and communications.

V. Final Hardscape Specialty, Landscape and irrigation Drawings

- A. Final Specialty Hardscape Plans
 - BLA will provide all detailing for the specialty areas included surfacing, steps and handrails, trash receptacles, benches and tables, and seatwalls to be installed throughout the park. Structural design is included for all walls necessary for the project.
 - Final landscape and irrigation plans showing quantities and locations for the landscape plans as well as all elements necessary for a working irrigation system matching existing irrigation components in Big Springs Park East.

VI. Final Electrical Plans

A. Electrical Plans

BLA will sub-contract with Hyde Engineering to provide an electrical plan for the entire site consisting of lighted walking paths, street lights along Church, as well as revising the food truck power as necessary with the updates to Church Street.



VII. Final Architectural Plans

A. Pavilion

BLA will subcontract with Nola Van Peursem Architects to provide architectural drawings for the pavilion for bidding purposes. Structural and electrical design is included in this portion of the design as it relates to the pavilions and shall be shown as a part of these drawings.

VII. Contract Administration

A. Bidding / Negotiation

These services are outlined below:

BLA will assist you in obtaining and evaluating bids and in negotiating and awarding all contracts for construction of the park work. This will include, in part, the following services.

The services provided in this phase include:

- a. Completion of the project manual for all specifications.
- b. Assisting you in qualifying bidders.
- b. Participating in pre-bid conferences.
- c. Preparing addenda to the Construction Documents.
- d. Attending bid opening
- e. Evaluating bids.
- f. Recommending and award of Construction Contract.
- g. Distributing required sets of contract documents. Consider, analyze, compare and make recommendations relative to alternatives or substitutions proposed by bidders or proposers either prior to or subsequent to receipt of bids or proposals.

B. Construction Administration

BLA will provide the following:

- Attend the Owner/ Architect Contractor meetings if requested.
- The Landscape Architect will represent the Client, as his agent, during the construction of the Landscape Work.
- The Construction Observation Phase will commence with the award of the Contract for Construction and will terminate when final payment to the Contractor is due, or in the absence of a final Certificate for Payment or of such due date, thirty (30) days after the Date of Substantial Completion of the Work, whichever comes first.
- The Landscape Architect is a representative of the Client during the Construction Phase. Instructions to the Contractor will be forwarded through the Landscape Architect.
- 5. Review progress or construction work for conformance of the Contract Documents on an average of one (1) day per week minimum for the full construction period.



- 6. The Landscape Architect will visit the site at appropriate intervals to become generally familiar with the progress and quality of the Work and to determine if the Work is proceeding in accordance with the Contract Documents. On the basis of on-site observations, the Landscape Architect will keep the Owner informed of the progress and quality of the Work and will endeavor to guard the owner against defects and deficiencies in the Work.
- 7. The Landscape Architect does not have control or charge of and is not responsible for construction means, methods, techniques, sequences or procedures, or for safety precautions and programs in connection with the work: for the acts or omissions of the Contractor, his Subcontractors or any other persons performing any of the Work, or for the failure of any of them to carry out the Work in accordance with the Contract Documents.
- Provide clarifications and coordination of documents in writing and/or sketches as requested by the owner.
- 9. The Landscape Architect will determine the amounts owed to the Contractor based on observations at the site and on evaluations of the Contractor's Applications for Payment, and will approve Certificates for Payment in such amounts. The approval of a Certificate for Payment is not a representation that the Landscape Architect has made any examination to ascertain how and for what purpose the Contractor has used the monies paid
- The Landscape Architect will review and approve or take other appropriate action upon the Contractor's submittals such as shop drawings, product data and samples for conformance with the design concept and conformance with the information given in the Contract Documents.
- 11. The Landscape Architect will prepare Change Orders for the Client's approval and execution, and will have authority to order minor changes in the Work not involving an adjustment in the Contract Sum or Contract Time.
- 12. Prepare Punch-list for consultant's scope of work and one (1) subsequent review that the work has been in conformance with the Contract Documents.

COMPENSATION FOR SERVICES

The fee for Items I-VIII will be a not to exceed amount of \$270,000.00 and includes final landscape architecture, architecture, civil, structural, and electrical engineering fees. This amount is based on the Alabama DCM basic fee rates for group III projects.

These fees will be billed as per the city's general service contract agreement. I request that our invoices be paid within 30 days of receipt, in order for us to provide uninterrupted services.

Should you request any services not mentioned in this proposal; those services will be performed at our appropriate hourly rates with an estimate of time first presented to you for review.

REIMBURSABLES

In addition to the above stated fees, all substantial print, courier, photographic, fax and long distance phone costs will be billed monthly at BLA or Consultant cost plus 15%. These reimbursable expenses will be billed along with the design fees.

ADDITIONAL SERVICES

Consists of professional services provided, if any, which are not described specifically above and as mutually agreed upon between the Client and the Landscape Architect. Examples of such services include, but are not limited to the following:

- A. Any consultation time spent dealing with or incurred by dealings with any government or municipal agency or office. This would include time above an allowance specified in the above scope of services. If no time is allowed for, these services would be provided on an hourly basis.
- Substantial increase in drawings or administration due to multiple contracts or multiple phases of work.
- C. Assisting the Client in arranging for the Work to proceed should the Contractor default due to delinquency or insolvency.
- D. Any construction administration for overseeing the implementation of the project.
- E. Providing prolonged administration of construction contract should the construction contract time be exceeded by more than thirty (30) days through no fault of the Landscape Architect.
- F. Preparing as-recorded drawings showing construction changes in Work or final locations of equipment, mechanical or electrical service lines and outlets, on the basis of data furnished by the Contractor.
- G. Revising drawings, specifications or other documents previously approved to accomplish changes requested by the Client.

SCOPE OF SERVICES

- A. Addition of the bathroom building for the project which will include all structural, mechanical and electrical services.
- B. Addition of the fountain consultant to the project
- C. Addition of the green roof to the project.
- D. Addition of the paver fix in the park
- E. Addition of the sidewalks from this site to the Breland entrance at the old bank
- F. Addition of the sidewalks from this site to the entry to the Truist garage and all ROW to complete this side of Fountain Circle from the square to the Truist garage entry.

COMPENSATION FOR SERVICES

Bostick LA -- \$50,200.00

Total for All both original and additional services - \$470,000.00.
