ADDENDUM 1 TO MASTER SERVICES AGREEMENT NO. 29149

The following will constitute an Addendum (Physical Destruction Agreement) to the contract between MCCi, LLC and City of Huntsville, AL (Addendum 1 - Scanning_Regular and Large Format - City-wide initiative - 2023/07/14) according to the following:

AGREEMENT

This agreement is made on **01.09.2025** by and between MCCi, LLC located at 3717 Apalachee Pkwy, Tallahassee, FL 32311, and **City of Huntsville**, **AL** at **305 Fountain Circle**, **Huntsville**, **AL 35801** (hereafter referred to as the Client) and is intended to document the understanding of both parties regarding the destruction of the clients' documents.

UNDERSTANDING

It is hereby understood that the Client has provided documents to MCCi for the purpose of scanning. Client is in receipt of the digital images, and the Client has no further interest in the physical documents. It is the Client's intention that MCCi dispose of the documents currently. Unless contracted otherwise, documents that do not contain sensitive or confidential data will be destroyed in a manner that is at the discretion of MCCi. MCCi may recycle, shred, burn, or in any other manner destroy documents. In no event will MCCi be held in any way responsible for any aspect of the destruction of said documents. If any costs are associated with the destruction of these documents, the client will be responsible for any cost incurred by MCCi. The Parties agree that any form of electronic signature, including but not limited to signatures via facsimile, scanning, or electronic mail, may substitute for the original signature and shall have the same legal effect as the original signature.

If the documents are confidential or contain sensitive data, the Client will contract with MCCi to professionally destroy the documents by shredding. The Client is responsible for paying any fees associated with the destruction, as written in the contract. MCCi will provide the Client with a Certificate of Destruction upon completion.
