## **MODIFICATION NO.1**

THIS MODIFICATION TO AN AGREEMENT is executed on this the <u>9th</u> day of <u>February 2023</u>, by and between the City of Huntsville, Alabama and Kimberly Erb as adopted by Resolution 22-97 on February 10, 2022. The City of Huntsville does hereby modify the contract to continue providing services for administrative support to grant programs in the Department of Community Development to the terms as follows:

The City of Huntsville hereby modifies the contract agreement dated February 10, 2022, as adopted by Resolution No. 22-97, to extend the term of this contract by ninety (90) days, commencing on <u>February 12, 2023</u>, thereby modifying the Agreement to end on <u>May 13, 2023</u>.

The previously established Not to Exceed amount of Thirty-Four Thousand Nine Hundred Forty-Four Dollars and NO/100's (\$34,944.00) for these services is hereby increased by the amount of Eight Thousand Seven Hundred Thirty-Six Dollars and NO/100's (\$8,736.00) thereby modifying the Not to Exceed amount to be Forty-Three Thousand Six Hundred Eighty Dollars and NO/100's (\$43,680.000).

The parties agree to modify the Agreement as adopted by Resolution 22-97 for these services as indicated in the recitals above and that the previously established term and Not to Exceed amount is hereby modified for a period of ninety (90) days set to commence on <u>February 12</u>, 2023, and conclude on <u>May 13</u>, 2023.

All other terms and conditions remain unchanged.
