## **RESOLUTION NO. 24-**

**WHEREAS**, an application has been made by Sara Y. Humphrey d/b/a Great Dane Limousine Service LLC, for a certification of public convenience and necessity for the operation of one (1) limousine in the City of Huntsville, and

**WHEREAS**, Ordinance No. 75-243 provides for the publication of a notice that such application has been made and setting a date for a public hearing.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, as follows:

- 1. That the intent of the City Council of the City of Huntsville, Alabama to consider whether a public convenience and necessity justifies the issuance of a limousine license to Sara Y. Humphrey d/b/a Great Dane Limousine Service LLC, for the operation of one (1) limousine is hereby declared.
- 2. That the City Council of the City of Huntsville shall meet at 5:30 P.M. on the <u>27th</u> day of <u>June</u>, 2024, at the Council Hall or at such other place announced by the Council in the City of Huntsville for the purpose of holding a public hearing on the question of whether public convenience and necessity justifies the issuance of a limousine license to Sara Y. Humphrey d/b/a Great Dane Limousine Service LLC, for the operation of one (1) limousine, at which time all parties may appear in person, by agent, or by attorney for the purpose of voicing objections or remonstrations.
- 3. That this resolution shall be published in the Speaking Out News, a newspaper of general circulation within the City of Huntsville, Alabama, said publication to be not less than seven days prior to the date of this hearing.
