ORDINANCE NO. 23-____

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of utility and drainage easements; that the applicants have represented to the City of Huntsville that Stephen and Leslie B. Cagle, are the owners of the property across which said easements lie; that said easements, or the portions being vacated, are not presently used and are no longer needed for a public or municipal purpose.

Section 2. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easements hereinafter described, said deed being substantially in words and figures as follows, to-wit:

Cagle, hereinafter referred to as Grantee, and other good and valuable considerations, the receipt and sufficiency whereof is hereby acknowledged, does hereby remise, release, quitclaim, and convey unto the Grantee, all of the Grantor's right, title, interest and claim in and to the following real estate situated in the City of Huntsville, County of Madison, State of Alabama, to-wit:

Particularly described as beginning at the Southwest corner of said Lot 6; Thence from the Point of Beginning and along the west boundary line of said Lot 6, North 00 degrees 13 minutes 53 seconds West 92.22 feet to the Northwest corner of said Lot 6; Thence North 89 degrees 03 minutes 04 seconds East 10.00 feet; Thence South 00 degrees 13 minutes 53 seconds East 92.22 feet; Thence South 89 degrees 03 minutes 04 seconds West 10.00 feet to the Point of Beginning.
