WHEREAS, on January 25, 2023, the City of Huntsville Electric Utility Board has approved an Agreement with Seven States Power Corporation to manage a project placing DC fast chargers (DCFCs) for electric vehicles (EVs) inside the City of Huntsville parking garage at 309 Pelham Avenue at a cost of \$526,218.00, 80% of which will be reimbursed by TVA, leaving Huntsville Utilities responsible for \$105,243.00; and

WHEREAS, said expenditure enables the placement of DC fast chargers for electric vehicles in the City of Huntsville; and

WHEREAS, the estimated cost of said Purchase is in excess of \$25,000.00 and requires the consent and approval of the City Council of the City of Huntsville, Alabama;

Subject: TVA Fast Charge Network & DCFC at Twickenham Square

In 2021, the TVA announced intent to work with LPCs in the valley to place DC fast chargers (DCFCs) for electric vehicles (EVs) every 50 miles throughout the region, primarily in close proximity to transportation corridors such as state, federal, and interstate highways. As an incentive, TVA is offering an 80/20 cost split by way of reimbursement for participating LPCs.

In conjunction with the City of Huntsville, HU staff have identified an ideal location for a DCFC inside the parking garage at 309 Pelham Ave., across from the Publix Supermarket at Twickenham Square. This parking garage is owned by the City of Huntsville, and city leadership is supportive of the project. HU has entered into a consulting agreement with the Seven States Power Corporation for the purpose of managing the project.

This is, however, an unbudgeted capital expense over \$25,000.00 and will therefore need Board and City Council approval to move forward.

Community Relations recommends approval of an unbudgeted capital expenditure of \$526,218, 80% of which will be reimbursed by TVA (with HU responsible for \$105,243), to construct a DCFC in the parking garage at Twickenham Square.
