This resolution declares a junk public nuisance at 4906 Clardy Rd NW and sets the date for a public hearing when comments can be made.

RESOLUTION NO. 26-

WHEREAS, the Manager of Community Development of the City of Huntsville, Alabama ("Director") has reported in a Report and Affidavit, a copy of which is attached hereto and incorporated herein by reference, that upon and/or in front of the property situated at 4906 CLARDY RD NW, Huntsville, AL, 35810, there exists certain conditions as those enumerated in Acts 1971, Reg. Sess., No. 71-1320, p. 2269, §2, which constitutes a public nuisance; and

WHEREAS, the Report and Affidavit of the Manager proves to the satisfaction of the City Council that the conditions that exist upon and/or in front of the referenced property constitute a public nuisance in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Huntsville, Alabama ("City Council") as follows:

1. That, in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269, the conditions as described in the Manager's Report and Affidavit existing upon and/or in front of the property at 4906 CLARDY RD NW, Huntsville, AL, 35810, more particularly described as follows wit: LOT 9 BL 3 HOLLY ACRES S/D , are found and hereby declared to be a public nuisance, which must be abated by the removal of said public nuisance.
2. That a meeting of the City Council shall be held at 5:30 pm, on February 26, 2026, in the City Council Chambers in the Municipal Building of the City of Huntsville, Alabama, in order to hear and consider all objections or protests, if any, to the proposed removal of said nuisance.
3. Community Development is hereby appointed to cause to be conspicuously posted in front of the property on which or in front of which the aforesaid nuisance exists, at not more than 100 feet in distance apart, but not less than two in all, notices headed, "Notice to Remove Public Nuisance", such heading to be in words not less than 1 inch in height and substantially in the following form:

NOTICE TO REMOVE PUBLIC NUISANCE

Notice is hereby given that on the 12th day of February, 2026, the City Council of the City of Huntsville, Alabama, passed a resolution declaring that a public nuisance exists upon or in front of the property at 4906 CLARDY RD NW, Huntsville, AL, 35810 in said City of Huntsville, Alabama, and more particularly described in said resolution, and that the same constitutes a public nuisance, which must be abated by the removal of said public nuisance, otherwise they will be removed and the nuisance will be abated by the municipal authorities, in which case the cost of such removal shall be assessed upon the lots and lands from which and/or in front of which such public nuisance is removed, and such cost will constitute a lien upon such lots or lands until paid. Reference is hereby made to said resolution for other particulars.

RESOLUTION NO. 26- (Cont'd)

All property owners having any objections to the proposed removal of said public nuisance are hereby notified to attend a meeting of the City Council of the City of Huntsville, Alabama, to be held at 5:30 pm, on 26th day of February, 2026 in the City Council Chambers in the Municipal Building of the City of Huntsville, Alabama, when their objections will be heard and given due consideration.

In addition, Community Development, is hereby ordered to mail a copy of said notice to the owner(s) of the property at least five days before the meeting at which objections will be heard, such notice to be mailed to the person last assessing the property for taxes according to the records of the Madison County Tax Assessor as well as to the current owner(s) of record according to the Madison County Probate Records if different than the owner(s) last assessed.




I have found to exist, as of 01/14/2026, a black Buick (engine in disrepair, not in road operable condition) and silver Toyota (engine in disrepair, not in road operable condition), located in rear yard, and a plastic bucket, bags filled with items, styrofoam containers, plastic basket filled with items, tools, auto mats, plastic material, cloth material, paper, auto rims, auto jacks, plastic containers, metal chains, weight bench and pull up bar, sledgehammer, light fixtures, rug, auto tire, auto lights, metal items, auto hubcap, engine parts, fish aquarium, tool box, interior tables, dishes, small appliances, plastic shelving, metal barrel, shoe rack, laundry basket, metal bucket, plastic tarp, dolly and other debris located on property and have determined that the stated conditions constitute a public nuisance (see attached hereto and incorporated herein by reference photographs of the subject property taken on 01/14/2026, which fairly and accurately shows how the property appeared on said date).

4. It is my recommendation that a public nuisance be declared to exist upon and/or in front of said property.
