TEMPORARY CONSTRUCTION AND LICENSE AGREEMENT

THIS TEMPORARY CONSTRUCTION AND LICENSE AGREEMENT (this "Agreement") is made and entered into as of the 11th day of July, 2024, by and between HYLIS, INC., an Alabama corporation, as Grantor, and THE CITY OF HUNTSVILLE, an Alabama municipal corporation, as Grantee.

WITNESSETH: That the Grantor for and in consideration of the sum of Ten and No/100 (\$10.00) Dollars, the promises of Grantee set forth below, and other good and valuable consideration to the Grantor in hand paid by the Grantee, the receipt whereof is hereby acknowledged, has this day granted, licensed, and conveyed and does by these presents grant, license and convey unto the said Grantee, its successors and assigns, including, but not limited to, its general contractor for the Park (defined below) a non-exclusive, temporary access, storage and construction license on, over, along, across, and through the portions of the lands of the Grantor situated in Madison County, Alabama, particularly described and depicted as follows:

Lot 3 of the Park, Phase 1 at Hays Farm, as recorded in Plat Book 2022, Page 77, in the Madison County Probate Records, also identified as PIN 576892 by the Madison County Tax Assessor ("Grantor's Property"),

for access; employee parking; temporary storage of materials, equipment and dirt stockpiles; location of one or more construction trailers/temporary offices; as a laydown yard for the windmill donated by Grantor's affiliate; and as a general staging area for the construction and development on Lot 1B of the Park Phase 3 at Hays Farm, as recorded in Plat Book 2022, Page 402 (the "Park"), with all such activity being in compliance with all government regulations and in a good and workmanlike manner, together with the unimpaired right of entry and re-entry from time to time as occasion may require for all the purposes above stated and under the conditions and for the period as stated below.

Grantee or its general contractor shall be responsible for obtaining all permits from the City of Huntsville (the "City") and/or any other governmental agency to be properly permitted for the Park project. Grantee shall remove any liens against the Grantor's Property caused by the work contemplated herein and shall restore the Grantor's Property to as good or better condition.

THE LICENSE AND RIGHTS GRANTED BY THIS INSTRUMENT SHALL TERMINATE AND ALL RIGHTS SHALL REVERT TO THE GRANTOR UPON THE COMPLETION OF GRANTEE'S PROJECT OR December 31, 2025, WHICHEVER SHALL FIRST OCCUR.

The parties all acknowledge that the SAMUEL H. GIVHAN, and the law firm of Lanier, Ford, Shaver & Payne, P.C., (collectively "Counsel") prepared this Agreement on behalf of and during his representation of the City. Counsel represents Grantor in various unrelated matters. For the purposes of this transaction, Counsel represents the City's interest and no other interests.

All conflicts of interest due to Counsel's representation of City and unrelated representation of the Purchaser are hereby waived.
