WHEREAS, the Cranston-Gonzalez National Affordable Housing Act of 1990, as amended, and associated regulations of the U.S. Department of Housing and Urban Development require that participating jurisdictions in certain community development programs of the Federal Government, including the Community Development Block Grant (CDBG) and the HOME Investment Partnerships (HOME) Programs, prepare, adopt, and carry out a Five-Year Consolidated Plan with Annual Action Plans; and

WHEREAS, the Annual Action Plan describes activities and programs that are aligned with the Five-Year Consolidated Plan and outlines the Community Development Block Grant (CDBG) and the HOME Investment Partnerships (HOME) Programs funds that will be available and the specific activities that will be undertaken each U.S. Department of Housing and Urban Development program year; and

**NOW THEREFORE BE IT RESOLVED,** by the City Council of the City of Huntsville, Alabama that the Mayor of the City of Huntsville be authorized, requested, and directed to submit the "2024 Annual Action Plan," a summary which is attached, to the U.S. Department of Housing and Urban Development, and to act in connection with the submission and to provide such additional information as may be required on behalf of the City of Huntsville, a municipal corporation in the State of Alabama. #### City of Huntsville 2024 Annual Action Plan Summary

The City of Huntsville Community Development Department oversees the implementation of the City of Huntsville's 5-year Consolidated Plan, Annual Action Plans, and programs funded by the U.S. Department of Housing and Urban Development (HUD).

The 2024 Action Plan represents the fifth year of the five-year 2020-2024 Consolidated Plan period. The Annual Action Plan outlines the activities that will be undertaken during the program year. In accordance with HUD's 2020-2024 strategic framework, the City affirms that it will make every reasonable effort to expend federal resources in Huntsville neighborhoods with the greatest need. Therefore, projects identified in the 2024 Action Plan will be primarily used to benefit households and individuals within the category of extremely low- to moderate-income, along with organizations serving these demographic groups.

The federally funded HUD programs covered by the Annual Action Plan are the Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME).

The 2024 Action Plan, through a collaborative process including community partners, service providers, nonprofit housing developers, housing authorities, City departments/divisions, and citizens, identifies community development needs and established goals that align and leverage community priorities and funding to further public initiatives.

# AP-15 Expected Resources – 91.220(c)(1,2)

The City of Huntsville receives Community Development Block Grant (CDBG) and HOME Investments Partnerships Program (HOME) entitlement funds that enable the City to direct important resources towards its low- to moderate-income neighborhoods, households, and individuals through various programs as outlined below. The table shows the annual funding amounts allocated to each program area. The 2024 Annual Action Plan provides a means by which HUD can ensure proper and efficient use of resources. As a requirement of the Annual Action Plan, HUD not only has an opportunity to review for appropriate use of funds but also has a benchmark document by which performance can be evaluated.

## **Anticipated Resources**

### AP-35 Projects – 91.220(d)

The distribution of funds for this fiscal year is based upon priorities developed in the Consolidated Plan. Allocations are approved based on a competitive solicitation of proposals from non-profit organizations, including social services agencies and affordable housing developers that are committed to provide housing and services to low to moderate income households, to prevent homelessness, to serve the homeless, to improve communities and to provide economic development opportunities.

Funding is allocated to entities carrying out eligible activities/projects/programs identified in the consolidated plan as a high priority. Requests are reviewed and evaluated on a number of criteria such as eligibility, organizational capacity, leveraging ability, number and income of citizens being served, and area being served. All activities/projects/programs are within a low/moderate income census tract or are programs that serve low/moderate income citizens, all within the City of Huntsville.

Common characteristics among these areas are:

- Higher percentages of households living below poverty
- Higher percentages of female headed households living below poverty
- Lower median incomes/over 50% of population are low- to moderate- income
- Lower per capita incomes
- Larger decline in median family income
- Higher percentage of unemployed
