WHEREAS, Junior Jordan, d/b/a A 24 Seven Taxi, has hereto made application to the City Council of the City of Huntsville for a Certificate of Public Convenience and Necessity for the operation of eight (8) taxicabs in the City of Huntsville; and

WHEREAS, a public hearing was held at 5:30 P.M. on the <u>27th</u> day of <u>February</u>, <u>2025</u> for the purpose of determining the public convenience and necessity for the operation of said service in accordance and provisions of Chapter 22 of the Code of Ordinances of the City of Huntsville as amended; and

WHEREAS, the City Council in making a determination of public convenience and necessity has taken into consideration the number of taxicabs and limousine businesses already in operation in the City, whether transportation is adequate to meet the public needs, the probable effect of additional taxicabs and limousines on local traffic conditions, the adequacy of the service which the applicant proposed to give, as well as other matters coming to the Council's attention.

NOW, THEREFOR, BE IT RESLOVED by the City Council of Huntsville, Alabama, that further taxicab service is required by public convenience and necessity, that said applicant is qualified and able to perform such transportation under the provisions of Chapter 22 of the Code of Ordinances of the City of Huntsville as amended.

BE IT FURTHER RESOLVED THAT THE City Clerck is hereby authorized and directed to issue a taxicab license to **Junior Jordan d/b/a A 24 Seven Taxi** for the operation of eight (8) taxicabs upon compliance with he provisions of said Chapter 22 of the Code of Ordinances of the City of Huntsville amended, and from year to year thereafter until the 1st day of January 2026, unless sooner terminated for cause as provided in said Chapter 22 of the Code of Ordinances of the City of Huntsville as amended.
