## ASSIGNMENT AND ASSUMPTION **AGREEMENT**

. This Assignment and Assumption Agreement (this "Assignment") is made effective March 27, 2025 (the "Effective Date") by and among the City of Huntsville (the "City"), Merrill Hudnall, DVM and Luminous Vet Services, LLC. In this Assignment, the City, Merrill Hudnall, DVM and Luminous Vet Services, LLC., are collectively referred to as the "Parties," and each, individually, as a "Party."

#### RECITALS

A. Merrill Hudnall, DVM and the City entered into a Professional Services Agreement (the "Agreement") effective as of November 21, 2024 (the "Agreement") pursuant to Huntsville City Council Resolution No. 24-889. Under the terms of the Agreement, the City authorizes Merrill Hudnall, DVM to provide professional services as a licensed veterinarian to the City's Animal Services Department.

B. As of the Effective Date, Merrill Hudnall, DVM has transferred the operation and services to Luminous Vet Services, LLC, an affiliate of Merrill Hudnall, DVM. Under the terms of this Assignment, the Parties wish to assign Merrill Hudnall, DVM's rights and obligations under the Agreement to Luminous Vet Services, LLC. To the extent a term is undefined in this Assignment, but is defined in the Agreement, the term has the meaning stated in the Agreement.

For and in consideration of the mutual covenants, rights, and obligations set forth in this Assignment, the Parties agree as follows:

- Assignment and Assumption. By this Assignment, Merrill Hudnall, DVM assigns the Agreement to Luminous Vet Services, LLC and Luminous Vet Services, LLC hereby assumes all of Merrill Hudnall, DVM's rights and obligations under the Agreement. The City expressly consents to Merrill Hudnall, DVM assigning all rights and obligations of the Agreement to Luminous Vet Services, LLC. This Assignment will be binding upon the Parties and their respective successors and assigns. This Assignment will not confer any rights or remedies upon any third parties.
- Insurance. Luminous Vet Services, LLC., shall provide a certificate of insurance to the City providing proof that Luminous Vet Services, LLC has insurance as required by the Agreement.
- Governing Law. This Assignment is to be governed and construed according to the laws of the State of Alabama without regard to conflicts of law.
- Counterparts. The Parties may execute this Assignment in any number of counterparts, each of which is 4. deemed an original, but all of which together constitute one and the same instrument. This Assignment may be executed by facsimile, PDF, or other electronic signature.
- Construction. All Parties have been advised to seek their own independent counsel concerning the interpretation and legal effect of this Assignment and have either obtained such counsel or have intentionally refrained from doing so and have knowingly and voluntarily waived such right. Consequently, the normal rule of construction to the effect that any drafting ambiguities are to be resolved against the drafting Party will not be employed in the interpretation of this Assignment.
- Notices and Submissions. All notices and payment under the Agreement are effective if hand delivered or sent by overnight courier or by certified mail return receipt requested to the following address.
