<u>Award Executive Summary:</u> This application is to request TOD Planning Pilot Program (20005b) funds in the amount of \$850,000.

The City of Huntsville was one of 20 communities in 16 states selected by the Federal Transit Administration for its Pilot Program for Transit-Oriented Development (TOD) Planning grant. This annual grant program provides funding to integrate land use and transportation planning with a new high-capacity transit project. The City of Huntsville has been awarded \$850,000. This is a 100% funded grant.

The University-Medical TOD Planning Study will identify opportunities for quality, transit-supportive development along the future high-capacity transit corridor. The study will focus on three clusters along University Dr. where opportunity for TOD is highest: Northwoods, UAH, and Mid-City. These clusters each present unique opportunities for residential development, including housing for essential workers, students, and families. The study will also develop conceptual designs of station areas and first/last mile connections in order to visualize how TOD might look along the corridor and link to nearby areas.

Affordable housing strategies were a priority in this years grant announcement, and the TOD study will examine a wide variety of policies for different housing needs. The total grant award is \$850,000100% Federal funds (no local match required). The study is expected to start this summer, with a final report in mid-2025.

Local entities that offered formal support for the project included Huntsville Hospital, Huntsville Housing Authority, the University of Alabama in Huntsville, and the Huntsville-Madison County Chamber of Commerce.

Research and Development: This award does not include research and development activities.

Indirect Costs: This award does not include an indirect cost rate.
