**WHEREAS**, by Resolution No. 06-187, adopted on February 9, 2006, the City Council of the City of Huntsville, Alabama ("Council") authorized the vacation of a portion of St. Clair Ave (the "Resolution").

WHEREAS, the United States of America was and remains the owner of the adjoining land on the north side of the portion of St. Clair Ave approved for vacation by the Resolution.

**WHEREAS**, on behalf of the United States of America, the Declaration of Vacation submitted to Council for the vacation of said right of way was executed by the Tennessee Valley Authority (the "TVA").

**WHEREAS**, that portion of right of way vacated pursuant to the Resolution was subsequently erroneously conveyed by Grantor to the TVA instead of the United States of America.

WHEREAS, pursuant to the Resolution, on July 10, 2014, the City executed a Quitclaim Deed conveying certain property, as further described therein, to the TVA (the "Original Deed"), and the Deed was recorded as Document Number20140710000363390 in the Probate Records of Madison County, Alabama.

WHEREAS, after adopting the Resolution, the City was informed by the TVA that the Grantee name was incorrect and that the legal description contained within the Original Deed contained an error.

WHEREAS, the City Council of the City of Huntsville, Alabama desires to adopt this Resolution to approve and authorize the execution of a corrective deed in order to correct the legal name of the Grantee and the legal description contained in the Original Deed.

**NOW THEREFORE, BE IT RESOLVED**, by the City Council of the City of Huntsville, Alabama, that the Mayor be, and he is hereby authorized, empowered, and directed to execute that certain Corrective Quitclaim Deed, by and between the City of Huntsville, an Alabama municipal corporation, as Grantor, and the United States of America, as Grantee, consisting of four (4) pages, including exhibits, and attached as Exhibit "A" hereto.

**BE IT FURTHER RESOLVED**, that the Mayor is hereby directed and authorized to have said Corrective Quitclaim Deed recorded in the Probate Records of Madison County, with an executed copy of said document to be permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama.

WHEREAS, on behalf of the United States of America, the Declaration of Vacation submitted to Council for the vacation of said right of way was executed by the Tennessee Valley Authority (the "TVA");

WHEREAS, that portion of right of way vacated pursuant to the Resolution was subsequently erroneously conveyed by Grantor to the TVA.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that the undersigned, CITY OF HUNTSVILLE, an Alabama municipal corporation, as Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) in hand paid by the UNITED STATES OF AMERICA, as Grantee, the receipt whereof is hereby acknowledged, and other good and valuable consideration, does hereby remise, release, quitclaim and convey unto the said Grantee, its successors and assigns, all of its right, title, interest, and claim in and to the following described real estate situated in the County of Madison, State of Alabama, to-wit (the "Property"), only insofar as the Property is not already owned by the United States of America by virtue of the Warranty Deed from the City of Huntsville recorded in Book 324, page 95 in the office of the Madison County Judge of Probate:
