Section 5307 IIJA BIL in the amount of \$3,652,643 and Section 5339 FFY 2025 in the amount of \$319,849. The local share will come from the City of Huntsville, Alabama, General Fund. This application will fund operating activities and capital rolling stock. The City of Huntsville, Alabama, is the designated recipient of Sections 5307 and 5339 Formula Program Funds. This project will contribute to the purchase of one (1) 40 FT buses, one (1) paratransit van, Preventative Maintenance and Huntsville Transit's Operating budget.

Purchase of the one (1) 40 foot bus for FY 2026, and partial funding for a second 40FT bus purchase for expansion. The remaining amount of funding for the second 40FT bus for expansion will come from FFY25 5339 funds that are requested for award in Project #3 of this grant application. The buses will be new, current year, with a useful life of 12 years/500,000 miles. The City has a contract with Gillig, Inc., that was procured with an RFP in FY2024.

Project Environmental Findings
