MODIFICATION NO. 2

THIS MODIFICATION IS MADE TO THE AGREEMENT entitled “Agreement Between the City of Huntsville, Alabama and Boys & Girls Clubs of North Alabama, Inc., as approved by Resolutions No. 24-452 and No. 25-183, for the use of CDBG funds” as referenced above and is entered into on this the 18th day of December, 2025 by and between the City of Huntsville, Alabama, hereinafter referred to as the Grantee, and Boys & Girls Clubs of North Alabama, Inc., hereinafter referred to as the Subrecipient.

WITNESSETH

WHEREAS, the Subrecipient has indicated a need to amend their Time of Performance (Section II);

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

Effective December 18, 2025, the Time of Performance (Section II) of the Agreement is deleted and replaced with the following:

I. TIME OF PERFORMANCE

Services of the Subrecipient shall start on July 1, 2023 and end on March 31, 2026. The term of this Agreement and the provisions herein shall be extended to cover any additional time period during which the Subrecipient remains in control of CDBG funds. The Subrecipient shall forfeit all funds not expended by the end of the term of this Agreement.


