SPECIAL EMPLOYEE AGREEMENT BETWEEN THE CITY OF HUNTSVILLE AND LARISSA SCHROEDER

SPECIAL EMPLOYEE AGREEMENT BETWEEN THE CITY OF HUNTSVILLE AND LARISSA SCHROEDER

THIS AGREEMENT is made and entered into on the <u>9th</u> day of <u>January</u>, <u>2025</u>, by and between LaRissa Schroeder, an individual, ("Schroeder") and the City of Huntsville, Alabama, a municipal corporation in the State of Alabama ("City"),

WITNESSETH:

In consideration of the mutual promises and covenants herein contained, the parties do hereby agree as follows, to wit:

- 1. Schroeder shall be employed by the City of Huntsville as Accountant II and shall be classified as a "Special" employee under the City's Personnel Policies and Procedures Manual.
- 2. The term of this contract shall be for a period of one year commencing on January 21, 2025.
- 3. This contract may be terminated by either party upon thirty (30) days written notice being provided to the other party.
- 4. Except as specified herein, Schroeder shall be subject to all Policies applicable to part-time employees of the City of Huntsville.
- 5. During the term of this contract, Schroeder shall perform the duties and responsibilities of Accountant II and shall be under the direct supervision of the Director of Water Pollution Control. Duties of the position of Accountant II shall include preparing fiscal reports and maintaining complex fiscal or related accounting records. Schroeder shall also be responsible for participating in the maintenance of budget accounts, reviewing receipts and documents to verify accuracy in relation municipal ordinances and state law and other general accounting duties as necessary.

- 6. Schroeder acknowledges that confidential information may be made available to her in connection with her work pursuant to this agreement. Schroeder agrees not to disclose the confidential information to any third party at any time following execution of this agreement. This clause shall survive the termination of this Agreement.
- 7. In consideration of the services rendered hereunder, the City shall pay Schroeder at the rate of \$53.57 per hour not to exceed 14 hours per week with the total sum Not to Exceed THIRTY-NINE THOUSANDAND NO/100 DOLLARS (\$39,000) per year which shall be paid bi-weekly in accordance with the City's regular payroll processing system. During the term of this agreement, Schroeder shall not receive any cost of living adjustment approved by the City Council for all other employees of the City. In addition, Schroeder shall not receive any benefits available to any employee of the City except those benefits he receives as a result of being retired from regular employment with the City. Schroeder shall have no authorization to incur any debt or obligation on behalf of the City.
- 8. This agreement constitutes the entire agreement between the parties.
